The filled up nomination paper, Affidavit, Undertaking along with other necessary documents in a **SEALED COVER** should be deposited in the sealed box kept in Room No. 123 (Accounts Office of the college) on working days between 10.00 a.m. to 5.00 p.m. but in no case later than 3.00 p.m. Wednesday, the 4<sup>th</sup> September, 2019.
5. The Demand Draft of Rs. 500/- from any Public Sector Bank in favour of 'Keshav Mahavidyalaya' should be submitted **SEPARATELY** while submitting nomination papers.
6. Withdrawal will be permitted if it is submitted only in writing in the prescribed format by the candidate in person with Fee Receipt of the current academic session. No withdrawal shall be allowed after 12.00 noon on Thursday, the 5<sup>th</sup> September, 2019.
7. Incomplete nomination form in any respect and absence of any document mentioned in the checklist (given at the end of this form) may lead to cancellation of nomination of the candidate.
