1. College Profile



Keshav Mahavidyalaya is a constituent off-campus college of the University of Delhi, established by the Govt. of NCT of Delhi in 1994. Our motto "Only Knowledge can provide salvation" has been the guiding principle for us in all our endeavors. Thus, we began our journey with a desire to impart education in different fields and shaping the young minds to make them empowered so that they can attain their fullest potential. The college has completed 29 years of its excellence in both academic and co-curricular domains, and has earned a distinguished reputation by providing a holistic learning atmosphere for students from diverse backgrounds. We can proudly say that 'Keshavites' in today's world have their mark in every sphere of life.

The 10 acres of green campus with a wide range of facilities is one of the finest campuses comprising of an air-conditioned Auditorium, Seminar Room, E-enabled Lecture theatres, well equipped laboratories, a well-stocked library, medical room, cafeteria, sports facilities and spacious ICT enabled classrooms. The College boasts of a spacious Girls Hostel with a capacity of 78 students on twin/triple sharing basis. Equipped with all necessary facilities, the hostel provides its residents many opportunities to fulfill their academic and cultural needs. Recently a new hostel wing for international female students has been added.

The college presently offers nine undergraduate programs under NEP 2020, in the disciplines of Science, Commerce, Management Studies, Psychology and Computer Science. The college also offers short-term courses (Certificate and Diploma) in Foreign Languages. The college with student strength of over 1800 has approximately 100 eminent faculty members and more than 60 non-teaching staff.

The college strives to maintain its place as one of the finest colleges by developing a system for conscious, consistent and catalytic improvement in its overall performance. To achieve this objective, the college has formed Internal Quality Assurance Cell (IQAC) which works for equitable and affordable access of academic programs for various sections of the society. It also facilitates the creation of learner's centric environment conducive to quality education.





2. Undergraduate Curriculum Framework (UGCF)

The Undergraduate Curriculum Framework (UGCF) is meant to bring about systemic change in the higher education system in the University and align itself with the National Education Policy 2020 (NEP). To actualize the noble objective, as succinctly brought out in the NEP - 2020, the University of Delhi has endeavored to explore the possibility of further restructuring and refinement of its undergraduate curriculum framework. All such efforts will be in line with the objective and underlying philosophy of the NEP – 2020 which is to capture the imagination of the youth of our nation and depict the contemporary realities of our demographic advantage globally. The following objectives of NEP are kept in perspective while framing UGCF:

- ▶ to promote the holistic development of students having the world view of a truly global citizen;
- ▶ to provide flexibility to students so that learners have the ability to choose their learning trajectories and programs, and thereby choose their paths in life according to their talents and interests;
- ▶ to eliminate harmful hierarchies among disciplines/fields of study and silos between different areas of learning; multidisciplinary and holistic education to ensure the unity and integrity of all knowledge;
- ▶ to promote creativity and critical thinking and to encourage logical decision-making and innovation;
- ▶ to promote ethics and human & Constitutional values;
- ▶ to promote multilingualism and the power of language in learning and teaching;
- ▶ to impart life skills such as communication, cooperation, teamwork, and resilience;
- ▶ to promote outstanding research as a corequisite for outstanding education and development;
- ▶ to incorporate Indian Knowledge System relevant for a particular discipline or field of studies.

2.1. Qualification Type and Credits Requirements

"Qualifications are formal 'awards' such as a certificate, diploma or a degree that are awarded by a competent authority such as a college or university in recognition of the attainment by students of the expected learning outcomes on the successful completion of a particular programme of study. They are awarded after an assessment and evaluation of learning levels conducted by a competent body that determines the achievement by students of the expected learning outcomes to given standards." A student who exits at the end of any even semesters has to earn the requisite credits (stated in Table - 3) in order to be awarded the relevant certificate/diploma/degree. The qualification title/nomenclature and corresponding credits requirements relevant for Level 5 to Level 8 of the undergraduate programmes are clearly stated in Table-1 below.

2.2. Structure of UGCF

The UGCF is a structure for four-year undergraduate programmes in different disciplines with multiple exit options. The details of the structure are provided below in Table-2.

There shall be choice in III and IV Semesters to choose either one 'SEC' or in the alternative 'Internship/Apprenticeship/Project/Community Outreach' in each Semester for two credits each.

** There shall be choice in Semester III and IV to either choose a DSE or a GE.

*** There shall be choice in V and VI Semesters to choose either one 'SEC' or in the alternative 'Internship/Apprenticeship/Project/Research/Community Outreach' in each Semester for two credits each.

There shall be four choices in VII and VIII Semesters –

- (i) to choose three DSEs of 4 credits each OR
- (ii) to choose two DSEs and one GE of 4 credits each OR
- (iii) to choose one DSE and two GEs of 4 credits each.

^ 'Research Methodology' shall be offered as one of the DSE courses in VI and VII Semesters. Students can opt for it either in VI semester or VII semester. However, a student pursuing multidisciplinary studies in three core disciplines shall have to choose research methodology in VI semester, if she/he wishes to Major in one of the three disciplines in the fourth year.

Suppose a student wishes to study the Research Methodology course offered by another discipline (as one of its DSEs). In that case, he/she may opt for it provided such discipline is his minor discipline. The Research Methodology of another discipline so opted shall be treated as GE for him/her.

Note:

- Entry level eligibility:** The general feeder category for entry into Level 5 is the Secondary School Leaving Certificate obtained after successfully completing Grade 12. A programme of study leading to entry into the first year of the Bachelor's degree is open to those students who have met the entrance requirements, including specified levels of attainment at the secondary level

of education mentioned in the programme admission regulations. Admission to the Bachelor degree programme of study is based on the evaluation of documentary evidence (including the academic record) of the applicant's ability to undertake and complete a Bachelor's degree programme which is specified in the UGC Guidelines for Multiple Entry and Exit Scheme in Academic Programmes Offered in Higher Education.

2. Number of hours of a credit course shall be defined by its component of lecture, tutorial and practical.
3. Every student has to study "Environmental Science and Sustainable Development" courses I and II of two credits each in the first year (I/II semester) and the second year (III/IV semester), respectively. The AEC pool will also consist of credit courses in languages listed in the Eighth Schedule of the Constitution of India, as updated from time to time. The University of Delhi shall extend necessary support to those Colleges (where faculty is not available) which may require it in course of teaching learning in these languages.
4. Design of degrees: Students shall be able to design their own degrees according to their mission and aspiration for a future befitting to their ability and attainment, rather than following the conventional pathway.
5. A student who pursues three years undergraduate degree programme in a specific discipline as a Core course [for example, B.A. (Hons.) English, B. Com (Hons.), B.Sc. (Hons.) Physics and such other Programmes] will earn at least 80 credits in that discipline (from 18 DSCs and at least 2 DSEs of that discipline) and shall be awarded Honours degree in that discipline, if he/she exits after completion of VI semester.
6. A student who pursues three years undergraduate degree programme in more than one discipline as core courses of study (for example B.A. in Social Sciences/ Humanities, B.Sc. in Life Sciences, B.Sc. in Physical Sciences, B.Sc. in Mathematical Sciences, Bachelor in Commerce Studies and such other programmes) he/she shall be awarded Bachelor's degree in that field of multidisciplinary course of study, if he/she exits after completion of VI semester. Please note that Keshav Mahavidyalaya offers B.Sc.(Prog.) Physical Sciences with Computer Science and B.Sc. (Prog.) Mathematical Sciences as multidisciplinary programs.
7. If a student wishes to pursue four years Honours Degree with research, he/she shall compulsorily opt for a Research Methodology course in either VI Semester or VII Semester as DSE.
8. Dissertation/Academic Project/Entrepreneurship in the 4 year shall commence from VII semester and conclude in VIII semester. Detailed outcomes of each track chosen out of these three options shall be notified and assessment at the end of VII and VIII semesters shall be done accordingly.
9. Dissertation may be written in the Major or Minor or Interdisciplinary (combination of Major and Minor) discipline.
10. If a student mentioned at (6) above continues or re-enters the fourth year for pursuing an Honours degree in that field of multidisciplinary study, he/she has to choose only one of the disciplines he/she had studied as core courses of study in the previous six semesters and earn credits from

the 2DSCs and 6DSEs of that chosen discipline in the VII and VIII semesters and write dissertation or opt for Academic Project or Entrepreneurship.

11. If a student mentioned at (5) above, continues or re-enters to study the VII and VIII semesters in the same discipline, and writes dissertation mentioned at (9) above, but no Minor discipline is made out (i.e., credits earned in the GEs of any one discipline is less than 28 credits), then he/she shall be awarded 'Honours with Research' with Major in that discipline on successful completion of VIII Semester.
12. A student mentioned at (6) above, shall be awarded 'Honours' degree in that field of multidisciplinary study on successful completion of VIII semester. For example, B.A. (Hons.) Social Sciences/ Humanities, B.Sc. (Hons.) Life Sciences, B.Sc. (Hons.) Physical Sciences, B.Sc. (Hons.) Mathematical Sciences and Bachelor in Commerce Studies (Hons.). Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(3)(b) and III(5)(b), respectively. For instance, a student who pursues four years B.A. (Hons.) in Social Sciences/ Humanities with History, Political Science and Hindi as core courses, shall get Major in History, on successful completion of VIII semester, if he/she earns minimum 80 credits in History from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History. Such a student shall get a Minor in Political Science/Hindi, if he/she earns minimum 28 credits from 6 DSCs and one DSE of Political Science/Hindi.
13. Only a student mentioned at (5) above who opts to write a dissertation in the Major/Minor subject in VII and VIII semesters in the fourth year, shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Research) in Discipline'. For instance, a student who pursues B.Sc. (Honours) in Physics and writes a dissertation on a topic relating to Physics or the Minor in VII and VIII semesters, shall be awarded 'Bachelor of Science (Honours with Research) Physics. Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(3)(a) and III(5)(a), respectively.
14. A student who opts for 'Academic Project' or 'Entrepreneurship' in VII and VIII semesters, instead of writing dissertations, and has earned 28 credits in the relevant GEs, SECs, AECs & IAPC, shall be awarded Minor in Academic Project or Entrepreneurship, as the case may be. 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major) & Academic Project/ Entrepreneurship (Minor)'. If he/she is unable to earn the

requisite 28 credits, he/she shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major).

15. A student who pursues four-year undergraduate degree programme shall be awarded after completion of the VIII semester an appropriate degree.
16. **Exit Options:** The minimum credit to be earned by a student per semester is 18 credits and the maximum is 26 credits. However, students are advised to earn 22 credits per semester. This provision is meant to provide students the comfort of the flexibility of semester-wise academic load and to learn at his/her own pace. However, the mandatory number of credits have to be secured for the purpose of award of Undergraduate Certificate/ Undergraduate Diploma/ Appropriate Bachelor's Degree in the field of Study/Discipline, to a student who chooses to exit at the end of even semesters (details provided in Table - 3).
17. The course title, code, number of credits, components of lecture, tutorial and practical, pre-requisites to be fulfilled for choosing that course and the department offering the course shall be spelt out for each course. A student should fulfil the pre-requisites of a course to be able to opt it for study.

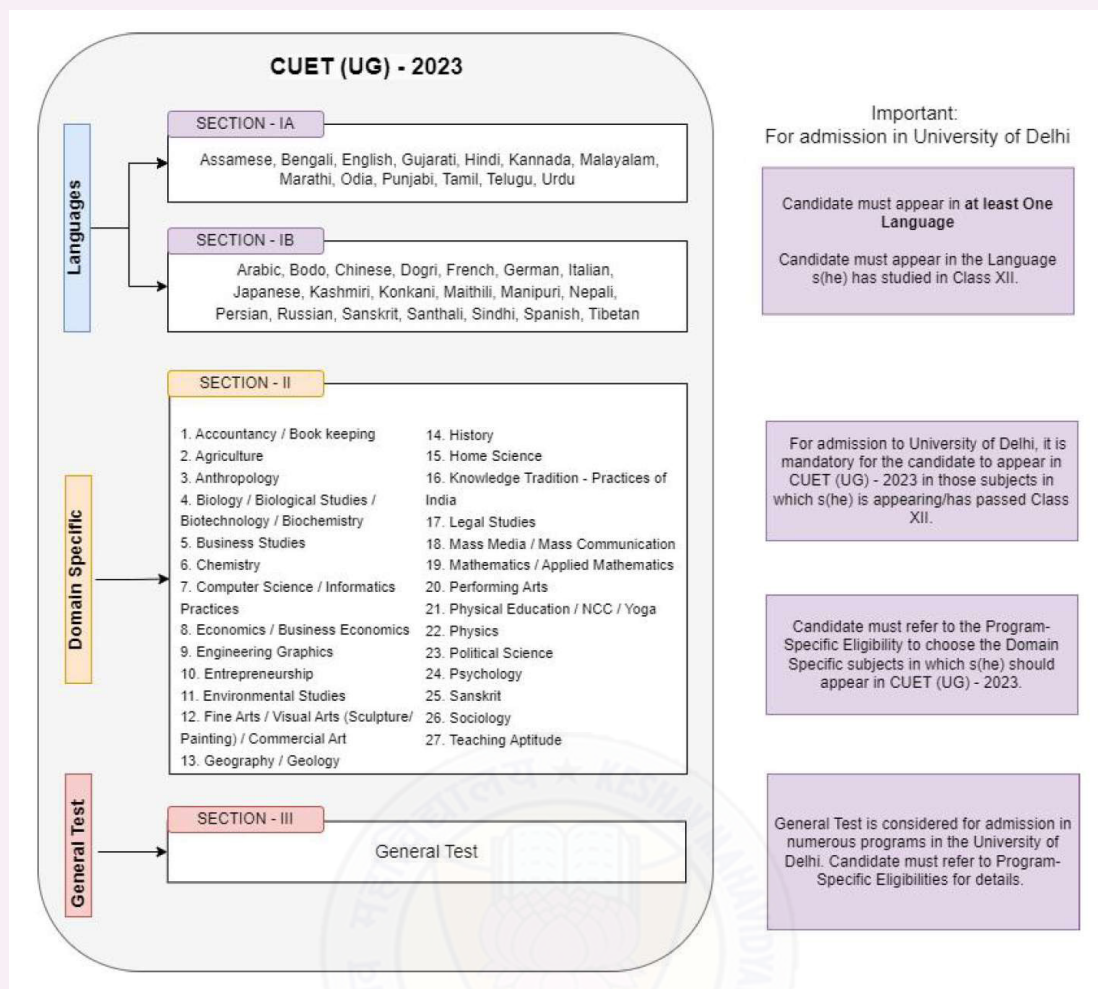
3. Admission Process to Undergraduate Programs

3.1. Structure of Common University Entrance Test (CUET) – 2023

- ▶ Candidates must carefully study the Program-Specific Eligibilities of Undergraduate programs of the University of Delhi before registering for CUET 2023 at <https://cuetsamarth.ac.in/>
- ▶ For admission to the University of Delhi, the candidates must appear in CUET in the subjects/ Test papers mentioned in the Program-Specific Eligibilities for which s(he) is desirous to take admission. Grievance related to non-appearance in CUET 2023 or the required subjects/test papers will not be entertained.
- ▶ Grievance related to non-appearance in CUET (UG) - 2023 in the required Languages and/or Domain Specific subjects will not be entertained.
- ▶ For all updates related to CUET, the candidates must visit the National Testing Agency (NTA) website: <https://nta.ac.in/>

3.2. Common Seat Allocation System (CSAS)

Admitting students through UoD's online platform Common Seat Allocation system (CSAS) (UG)-2023 is binding on all colleges of University of Delhi. Admission to all UG programs are done on the basis of eligibility requirements, criteria and procedures specified by the University on its website. 3.3. Important Points

- Admissions to all Undergraduate Programs at the University of Delhi will be based on the scores obtained in CUET (UG) – 2023, except for admissions to the School of Open Learning (SOL), Non- Collegiate Women Education Board (NCWEB) and Foreign Nationals.
- An eligible candidate desirous of seeking admission to the Undergraduate Programs(s) of the University of Delhi for the academic session 2023-24 must read the contents of this Bulletin of Information, as well as the notifications, updates and information published on the admission website of the University of Delhi very carefully.
- The candidate must have studied and passed Class XII Examination or its equivalent from a single recognized board.
- The candidate must have passed Class XII examination of any Board / University examination in India, or any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- For admission to University of Delhi, it is mandatory for the candidate to appear in CUET (UG) - 2023 in those subjects in which s(he) is appearing/has passed Class XII.
- In case the subject studied at Class XII is not mentioned in the CUET (UG) - 2023, the candidate must appear in the Language/Domain Specific subject that is similar/closely related to the

subject s(he) has studied at Class XII (for example, if a candidate has studied Biochemistry in Class XII, s(he) must appear in Biology in CUET (UG) - 2023.

7. Admission will be based only on the combination of scores of Language and/or Domain Specific subjects in which a candidate has appeared in CUET (UG) – 2023 as per the respective Program-Specific Eligibility.
8. Only the scores obtained in CUET (UG) - 2023 will be considered for admissions to the academic year 2023-24.
9. Candidates must study the Program-Specific requirements carefully and then appear in Language and/or Domain Specific subjects of the CUET (UG) - 2023.
10. The candidate is advised to check that s(he) satisfies all eligibility criteria for the program(s) for which s(he) is appearing in the entrance test. Admission is subject to the candidate's fulfilling the eligibility requirements prescribed for applying to the concerned program of study. In case a candidate does not meet any eligibility criteria prescribed for applying to the concerned program and appears in the entrance test, it is at the candidate's own risk and cost. If at any stage, it is found that eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso facto.
11. Before registering for CUET (UG) - 2023, the candidate is advised to carefully read the Bulletin of Information and consult the University of Delhi Act, 1922 and the Statutes. The Ordinances, 10 Rules, and Regulations of the University of Delhi, available on the University website, would be binding on him/her.
12. Candidates must be careful while filling the CUET(UG)-2023 form as certain fields such as Name, signature, and photograph of the candidate will be later auto-integrated by the University of Delhi from CUET(UG) – 2023. These fields will be non-editable.
13. As per Ordinance-I of the University of Delhi, there is no minimum age bar for admission to the undergraduate programs in the University and its colleges except in the programs where the respective regulatory bodies, such as the Medical Council of India (MCI), All India Council for Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.
14. Gap year will not be a bar for the purpose of admission to undergraduate programs. However, such candidates must also appear in CUET (UG) - 2023 for admissions in the academic year-2023-24.
15. The name of the Candidate claiming reservation must match with the Candidate's name as it appears on their corresponding School Board qualifying certificates and in CUET(UG) - 2023. Similarly, the parents' names must also match in the certificate.

4. Eligibility Requirements for UG Admissions

4.1. Common Minimum Eligibility

The candidate must have passed the Class XII or its equivalent examination from a single recognized board.

In case a candidate has passed subjects/s from more than one board, s(he) can appear for CUET 2023 in the subjects in which s(he) has passed Class XII; however, for the purpose of ascertaining the Minimum Eligibility, the marksheet/ degree of only one board will be considered (For example, If a candidate has appeared in CBSE Board Examination with five subjects except for Mathematics and later appears and passes Mathematics from another board such as the National Institute of Open Schooling (NIOS), the minimum eligibility shall be ascertained from his/her marksheet issued by CBSE only).

The marks obtained by the candidate in CUET 2023 will be considered for computing the total marks according to the Program-Specific combinations of subjects for deciding merit and granting admissions in the undergraduate programs. Merit will be based only on the ‘combination of subjects in which a candidate has appeared in CUET 2023’ as mentioned in the respective Program-Specific Eligibility.

Note: For admission to University of Delhi, it is mandatory for the candidate to appear in CUET (UG) – 2023 in those subjects in which s(he) is appearing/has passed in Class XII.



5. UG Programs and Courses Offered by the College

5.1. Undergraduate Programs and Program Specific Eligibility

B.Com (Hons.)

B. Com. Candidates must appear in CUET in any one of the following two subject combinations:

Combination I: Any one Language from List A + Mathematics + Any two subjects out of which at least one should be from List B1.

Combination II: Any one Language from List A + Accountancy + Any two subjects out of which at least one should be from List B1.

Merit will be based on the best CUET scores obtained from any of the above-mentioned combinations of subjects.

B. Sc. (Hons.) Computer Science

The B.Sc. (Hons.) Computer Science curriculum offers to develop theoretical foundations in computer science to build computational thinking, analytical, and problem-solving skills. The program prepares the students for higher studies in Computer Science and its applications. The program aims to produce skilled graduates with a creative mindset who can recognize a computational problem either in IT industry or society and develop effective solutions. In addition, the students develop expertise in programming skills using contemporary programming languages used by the software industry. It covers core computer science topics like computer systems architecture, data structures, computer networks, operating systems, computer graphics, algorithms, software engineering, database management, theory of computation, artificial intelligence, and information security.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Any one language from List A + Mathematics + Any two subjects out of which one should be from List B1

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

B. Sc. (Hons.) Electronics

In recent years, Electronic Science has made unprecedented growth in new technologies, new ideas and principles. The B.Sc. (Hons.) Electronic Science curriculum offers undergraduates a complete package to understand the fundamentals of advanced electronics. They can equip themselves with electronics fundamentals with a comprehensive skill set compatible with industry 4.0 standards. The exhaustive curriculum will prepare them to pursue higher education and compete in the job market. The program covers embedded systems, advanced computer and data communication, robotics, control systems, VLSI Design and Fabrication, Nanoelectronics, Artificial Intelligence, Internet of Things and others.

Program Specific Eligibility

Candidates must appear in CUET in any of the following two subject combinations:

Combination I: Physics + Mathematics + Chemistry

Combination II: Physics + Mathematics + Computer Science/Informatics Practice

Merit will be based on the best CUET score obtained from any of the above-mentioned combinations of subjects.

Candidates must have obtained a minimum of 30% score in any one language of List A in CUET.

B.Sc. (Hons.) Mathematics

The B.Sc. (Hons.) Mathematics program aims at developing the ability to think critically, logically, and analytically and hence use mathematical reasoning in everyday life. Pursuing a degree in mathematics will introduce the students to several interesting and valuable ideas in preparation for several mathematics careers in education, research, the government sector, the business sector and industry. The B.Sc. (Hons.) Mathematics program covers the full range of mathematics, from classical Calculus to Modern Cryptography, Information Theory, and Network Security. The program lays a structured foundation of Calculus, Real & Complex analysis, Abstract Algebra, Differential Equations (including Mathematical Modelling), Number Theory, Graph Theory, and C++ Programming exclusively for Mathematics.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Any one language from List A + Mathematics + Any two subjects out of which one should be from List B1

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

B. Sc. (Prog.) Mathematical Sciences

A well-structured Mathematical component in B.Sc. (Prog.) Mathematical Sciences empowers the students to: Solve problems using a broad range of significant mathematical techniques, including calculus, algebra, geometry, analysis, numerical methods, differential equations, probability and statistics, along with hands-on learning through CAS and LaTeX. One of the program's aims is to combine the principles of physics and chemistry, as supported by mathematics, to describe the foundational concepts of the physical world and apply these concepts to new situations. Collaborate with others, including multidisciplinary groups, to solve scientific problems and recognize ethical issues in each profession; logical question assertions and recognizing patterns are other highlights of the Program.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Any one language from List A + Mathematics + Any two subjects out of which one should be from List B1

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

Bachelor of Management Studies (BMS)

Bachelor of Management Studies or BMS is an undergraduate program for management studies. The course allows students to obtain the knowledge and skills needed to assume management positions in a wide range of organizations. The management Studies program provides students with a solid foundation in the field of management and strategy designing. The electives allow students to develop deeper knowledge in specific areas of interest – finance, marketing, human resource management and management of the global business. In addition to the business management course, it will equip students to understand how organizations work, how they are managed and sensitize students towards national and international environments. Students centered learning focuses on skills and practices that enable lifelong learning and independent problem-solving.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Any one Language from List A + Mathematics + SECTION III of CUET (General Test)

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

B. Sc. (Prog.) Physical Sciences with Computer Science

The program provides skills to design, implement, and evaluate the computer-based system and apply knowledge of computing to solve computational problems by understanding computer systems, fundamentals, and their application related to physical sciences. In addition, it provides the ability to communicate effectively with a range of audiences.

Program Specific Eligibility

Candidates must appear in CUET in any of the following two subject combinations:

Combination I: Physics + Mathematics + Chemistry

Combination II: Physics + Mathematics + Computer Science/ Informatics Practices

Merit will be based on the best CUET score obtained from any of the above-mentioned combinations of subjects.

Candidates must have obtained a minimum of 30% score in any one language of List A in CUET.

B. Sc. (Hons.) Physics

Physics is an experimental and theoretical science that systematically studies the laws of nature operating at length scales from the sub-atomic domains to the entire universe. The core areas of study within the disciplinary/subject area of the B.Sc. (Hons.) Physics program are: Classical and Quantum Mechanics, Electricity and Magnetism, Thermal and Statistical Physics, Wave theory and Optics, Physics of the Materials, Digital Electronics, and specialized methods of Mathematical Physics and their applications in different branches of the subject. Along with the theoretical course work, students also learn physics laboratory methods for different branches of physics, specialized measurement techniques, analysis of observational data, including error estimation, and scientific report writing. The latest addition to Physics pedagogy is computational physics, which involves adapting Physics problems for algorithmic solutions and modelling and simulation of physical phenomena.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Physics + Chemistry + Mathematics

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

Candidates must have obtained a minimum of 30% score in any one language of List A in CUET.

B. A. (Hons.) Psychology

Through this program, the students get an opportunity to understand and learn the historical influences of psychology as a discipline. The curriculum addresses the fast-paced changes in the subject matter. The curriculum and pedagogy of Psychology are sensitive to the advances in the knowledge, application, and research possibilities in Psychology. The undergraduate coursework in Psychology touches upon the diverse areas of the discipline, including biopsychology, cognitive psychology, history of psychology, research methods, social psychology, Industrial/Organizational psychology, counseling psychology, health psychology and others.

Program Specific Eligibility

Candidates must appear in CUET in the following subject combination:

Any one Language from List A + Any two subjects from List B1 + Any one subject from either List B1 or List B2

Merit will be based on the CUET scores obtained from the above-mentioned combination of subjects.

Note: A candidate will be admitted provisionally on successful realization of the Admission Fee. The admission fee must be paid only through the candidate's dashboard. If the admission fee is not successfully remitted within the stipulated time, the admission will not be considered complete under any circumstances. For all payments, candidates should use any of these payment modes: Net Banking / Debit Card / Credit Card / UPI. The admission shall be confirmed only after the physical verification of all relevant documents in the college.

7. Fee Refund Policy in Case of Admission Withdrawal



A candidate who has taken admission in a program but wishes to withdraw from it can do so through his/her dashboard of the admission portal by selecting the 'Withdraw' option and paying a withdrawal fee of Rs. 1000.00 (nonrefundable). A candidate who withdraws his/her admission will forfeit his/her eligibility for admission to UG Programs of UoD. No further participation in any of the subsequent regular allocation rounds, if any, will be allowed. The Withdrawal option will be suspended on the announcement of the Spot Admission round/s.

On account of the withdrawal of the admission by the candidate, the full admission fee will be refunded only if the withdrawal has been made before the last date of admission, as announced by UoD. Admission fees for withdrawals done after the last date of admission will not be refunded under any circumstances.

Refunds will not be done for the following:

- a) CSAS(UG)-2023 Application Fee.
- b) Mid-Entry Fee.
- c) Withdrawal Fee.

On the closure of admissions, refund process will be initiated. The UoD will try to settle the refunds within three months of closure of admissions. Candidates are required to follow the University of Delhi website for further updates.

8. Reservation Policy

8.1. Reservation of Seats for Scheduled Caste (SC) and Scheduled Tribe (ST) Candidates

22.5% of the total number of seats is reserved for Candidates belonging to Scheduled Castes and Scheduled Tribes (15% for Scheduled Castes and 7.5% for Scheduled Tribes, interchangeable if necessary).

The Candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission. The Caste certificate should clearly state:

- a) Name of his/her caste/tribe
- b) Whether the candidate belongs to SC or ST
- c) District and the State or Union Territory of Candidate's usual place of residence, and
- d) The appropriate Govt. of India Schedule under which his / her caste / tribe is approved as SC or ST.

The Candidate will have to produce the valid original SC or ST caste/tribe certificate at the time of admission.

The following are empowered to issue the requisite SC / ST certificate:

- a) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
- b) Chief Presidency Magistrate / Addl. Chief Presidency Magistrate / Presidency Magistrate.
- c) Revenue Officer not below the rank of Tehsildar.
- d) Sub - Divisional Officer of the area where the Candidate and/ or his family normally resides.



e) Administrator / Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

Candidates to note that **the SC / ST Certificate from any other person / authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste / tribe must be listed in the appropriate Govt. of India Schedule.**

It is a statutory obligation on the part of colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe Candidates.

Colleges shall not refuse admission to any SC / ST Candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.

8.2. Reservation of Seats for Other Backward Classes (OBC, Non-Creamy Layer, Central List)

27% seats are reserved for the Candidates belonging to Other Backward Classes (OBC - Non-Creamy Layer, Central List).

At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website http://ncbc.nic.in/backward_classes/index.html.)

The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993).

The OBC Candidates who belong to the 'Non-Creamy Layer' and **whose caste appears in the Central List of the OBCs only**, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the Candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res- I) dated 31 March 2016). The certificate should be issued on or after 31st March, 2023.

It is a statutory obligation on the part of colleges to fill all the seats reserved for OBC Candidates.

8.3. Reservation policy for Economically Weaker Sections (EWS)

As per the University of Delhi notifications (Reference No. Aca. I / Reservation of EWSs / 2019/ 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission of candidates belonging to

EWS category. The certificate should be issued on or after 31st March, 2023.

8.4. Admission to Supernumerary Seats

Admission to all supernumerary seats will be through CUET (UG) - 2023. **Candidates desirous of taking admission on Supernumerary seats must appear in CUET (UG) - 2023.**

8.4.1. Persons with Benchmark Disabilities (PwBD)

A. Locomotor Disability

Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—

1. **"leprosy cured person"** means a person who has been cured of leprosy but is suffering from—
 - i. loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifestation of deformity;
 - ii. manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
 - iii. extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
2. **"cerebral palsy"** means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
3. **"dwarfism"** means a medical or genetic condition resulting in an adult height of 4feet 10 inches (147centimeters) or less;
4. **"muscular dystrophy"** means a



group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;

5. **"acid attack victims"** means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

B. Visual impairment

1. **"blindness"** means a condition where a person has any of the following conditions, after best correction
 - i. total absence of sight; or
 - ii. visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
 - iii. limitation of the field of vision subtending an angle of less than 10 degree.
2. **"low-vision"** means a condition where a person has any of the following conditions, namely:
 - i. visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
 - ii. limitation of the field of vision subtending an angle of less than 40 degree upto 10 degree.

C. Hearing Impairment

1. **"deaf"** means persons having 70 DB hearing loss in speech frequencies in both ears;
2. **"hard of hearing"** means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
3. **"speech and language disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

D. Intellectual Disability

A condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—

1. **"specific learning disabilities"** means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and

developmental aphasia;

2. **"autism spectrum disorder"** means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

E. Mental Illness

"Mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by subnormality of intelligence.

F. Disability caused due to Chronic neurological conditions, such as—

1. **"multiple sclerosis"** means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
2. **"Parkinson's disease"** means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

7. Blood Disorder

1. **"haemophilia"** means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding.
2. **"Thalassemia"** means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin.
3. **"Sickle cell disease"** means a haemolytic disorder characterised by chronic anaemia, painful events, and various complications due to associated tissue and organ damage; "haemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.

H. Multiple Disabilities (more than one of the above specified disabilities)

Multiple disabilities including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

I. Any other category as may be notified by the Central Government.

Concessional/Waiver of fees in respect of Persons with Benchmark Disabilities (PwBD)

- a. Candidates with physical disabilities pursuing various programs of study in the Faculties, Departments, Centres, and Institutions / Colleges of the University shall be **exempted from payment of fees, including examination fee and other University fees**, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee (As per amendment to Ordinance X(4) of the University).
- b. PwBD Candidates who meet the merit for the unreserved category and will take admission in the unreserved category (UR) will pay the fee relevant to PwBD Candidate.
- c. As per the Executive Council Resolution No. 50 dated 03.11.2012, students with physical disabilities residing in different Hostels / Halls of the University **are exempted from payment of all hostel fees and charges** except refundable caution fees and the mess fees. Persons with Physical Disabilities who are students shall pay 50% of the Mess fee and the remaining 50% of their Mess Fee will be met by the University of Delhi. **Similar norms are to be adopted by the Colleges in respect of PwBD Students residing in various hostels of the Colleges.**
- d. PwBD students who are getting fellowships / financial assistance shall be exempted from payment of fees / charges / mess fees subject to the following conditions.

Upto 3000/- per month	Fees waiver + 50% Mess Subsidy
3001/- to 8000/- per month	Fees waiver but no Mess Subsidy
8001/- and above per month	No fees waiver and no Hostel Subsidy

Candidates must ensure that the PwBD certificate is in the name of the candidate and issued by a recognized Government Hospital, bearing duly attested photograph of the candidate.

8.4.2. Children/Widows of Personnel of the Armed Forces (CW)

Five percent (5%) of seats are reserved for Candidates under this category, program-wise in all colleges.

Candidates desirous of taking admission under the CW quota of the University **must appear in CUET (UG) - 2023.**

All such Candidates have to upload the Educational Concession Certificate (ECC) issued by any of the following authorities on the proper letterhead:

- a) Secretary, Kendriya Sainik Board, Delhi.
- b) Secretary, Rajya Zila Sainik Board.

- c) Officer-in-Charge, Record Office.
- d) 1st Class Stipendiary Magistrate.
- e) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered*.

Admission may be offered to the Children/Widows of Personnel of the Armed Forces (**Priority to IX**) including Para- Military Personnel (**only Priority I to V**), in the following order of preference:

Priority I	Widows/Wards of Defence personnel killed in action;
Priority II	Wards of Defence Personnel disabled in action and boarded out from service with disability attributable to military service;
Priority III	Widows/Wards of Defence Personnel who died while in service with death attributable to military service;
Priority IV	Wards of Defence Personnel disabled in service and boarded out with disability attributable to military service;
Priority V	Wards of Ex-servicemen and Serving personnel, including personnel of police forces who are in receipt of Gallantry Awards; <ul style="list-style-type: none"> i. Param Vir Chakra ii. Ashok Chakra iii. Maha Vir Chakra iv. Kirti Chakra v. Vir Chakra vi. Shaurya Chakra vii. President's Police Medal for Gallantry/President Gallantry Medal for the fire services personnel viii. Sena Medal (Gallantry), Nau Sena Medal (Gallantry), Vayu Sena Medal (Gallantry) ix. Mention-in-Despatches x. Police Medal for Gallantry/Gallantry Medal for fire services
Priority VI	Wards of Ex-Servicemen.
Priority VII	Wives of: <ul style="list-style-type: none"> i. Defence personnel disabled in action and boarded out from service. ii. Defence personnel disabled in service and boarded out with disability attributable to military service iii. Ex-servicemen and serving personnel who are in receipt of Gallantry Awards.
Priority VIII	Wards of Serving Personnel
Priority IX	Wives of Serving Personnel

*The University may ask for supporting documents along with ECC.

8.4.3. Kashmiri Migrants (KM)

Up to 5% seats are reserved program-wise in all colleges for the wards of Kashmiri Migrants. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/ Relief Commissioner.

Candidates desirous of taking admission under the Kashmiri Migrants quota **must appear in CUET (UG) - 2023.**

8.4.4. Prime Minister's Special Scholarship Scheme for J&K students

Candidates desirous of taking admission under the Prime Minister's Special Scholarship Scheme for J&K students **must appear in CUET (UG) - 2023.**

8.4.5. Nomination of Seats for Sikkimese Students

Candidates desirous of taking admission under the Sikkim nomination scheme **must appear in CUET (UG) - 2023.**

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion.

8.4.6. Ward Quota of Employees of University of Delhi

Candidates desirous of taking admission under the Ward Quota of Employees of University of Delhi **must appear in CUET (UG) - 2023.**

Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020 and subsequent amendments thereof.

Candidates must be in possession of a valid Employment Certificate issued by due officials at the time of registration. Only the Employment certificate uploaded at the time of registration will be considered. I-cards, Aadhar Card and/or any other document will not be accepted.

8.4.7. Orphans Quota

Candidates desirous of taking admission under the supernumerary Quota for Orphans **must appear in CUET (UG) - 2023.**

The University of Delhi will be admitting two candidates (one male and one female) in each program of study, both at the Undergraduate and Postgraduate level, . These two seats will be supernumerary. The Council of the University further resolved that the expenditure incurred for admission and continuance of study of such students in the University or its Colleges shall be met from the University Welfare Fund or College Students' Welfare Fund, as the case may be, for admissions in the University or in the College.

8.4.8. Extra-Curricular Activities (ECA) and Sports Quota

Candidates desirous of taking admission under the supernumerary quota for ECA and/or Sports **must appear in CUET (UG) - 2023.**

For admissions to ECA and Sports supernumerary seats a weightage of 25% will be given to CUET score and 75% to certificates/trials/performances.

Please refer to Section 5.6 and 5.7 regarding the distribution of seats for ECA and Sports in Keshav Mahavidyalaya.



9. Admission to NCWEB and SOL (DDCE)

9.1. Non-Collegiate Women's Education Board (NCWEB)

The NCWEB is a constituent part of the University of Delhi which has been contributing to the empowerment of women through education since 1944. It enables thousands of young women who cannot join regular college for various reasons to attend classes during Saturdays/Sundays and during academic breaks to obtain Undergraduate and Postgraduate Degrees from the University of Delhi. NCWEB facilitates the female students of NCT Delhi to take University of Delhi examinations and classes are held once a week. NCWEB has emerged as an important academic option for female students. Keshav Mahavidyalaya has been the centre of two Undergraduate programs namely B.Com and B.A. Program under NCWEB and holds classes on Saturdays only. Admission to the above programs is based on the merit score obtained in Class XII. Candidates desirous of taking admission to the Non-Collegiate Women Education Board (NCWEB) must register at the NCWEB admission website at <https://ncwebadmission.uod.ac.in/>. The registration process has begun on 14th June 2023. Candidates are advised to check the website regularly for any updates.

9.2. School of Open Learning (Department of Distance and Continuing Education)

Under the ambit of the University of Delhi, the School of Open Learning (Department of Distance and Continuing Education), imparts quality higher education through distance mode. There are eight (08) Undergraduate programs namely B.A. Program, B. Com, B. Com (Hons.), B. A. (Hons.) English, B. A. (Hons.) Economics, B. A. (Hons.) Political Science, BBA (FIA) and BMS.

Admission to the above programs is based on the merit score obtained in Class XII.

Candidates desirous of taking admission to the School of Open Learning (SOL) must register at www.sol.du.ac.in.

11. College Life

11.1. Infrastructure

At Keshav Mahavidyalaya, we believe in hands-on experience for the students. As theoretical knowledge alone is insufficient and incomplete, well-equipped laboratories have been set up in all the relevant programs.

11.1.1. Electronics Laboratory

The Department of Electronics has well-equipped laboratories which are the backbone of the Department and contribute significantly to the practical adeptness of the students. These Laboratories are used to perform experiments based on Analog electronics, Digital circuits and Systems, Instrumentation, Communication and Signal Processing and Microprocessor Applications. Students develop a working knowledge of various integrated circuit families, circuit designing, ROM, EPROM, and RAM.



11.1.2. Computer Laboratory



The computer wing has three spacious computer laboratories equipped with state-of-the-art facilities. All the systems are of the latest configuration. The laboratories can accommodate approximately 90 systems apart from servers. There is a separate UPS room. The laboratories have a wireless LAN using Wi-Fi Routers. It also provides multimedia facilities and is equipped with an OHP, LCD Projector, and Scanner.

11.1.3. Physics Laboratory

The college has two well-equipped air-conditioned Physics laboratories, equipped with the latest and sophisticated instruments, which are used for practical work related to mechanics, optics, heat and electrical circuits, computer programming, solid state physics etc. Separate air-conditioned dark rooms are also available for performing experiments related to optics and ballistic galvanometers. The laboratories are continuously upgraded to ensure that the students are equipped with the latest skills.



11.1.4. Chemistry and Biology Laboratories



There are two chemistry laboratories designated for performing Organic, Inorganic, Physical, and Analytical experiments and are furnished with modern instruments like electronic balances, electrophoresis machines, digital pH meters, and potentiometers. A fully air-conditioned analytical technique laboratory is also being set up. The biology laboratories are well equipped too. Computer facilities are also available in both laboratories.

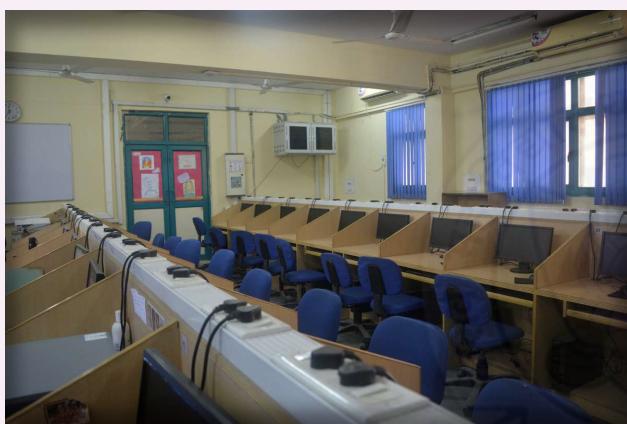
11.1.5. Psychology Laboratory

The Psychology laboratory of the college is well equipped with the latest psychological tests and instruments, and new ones are added every year to give wide exposure to students. The psychometric tests are applicable in clinical, organizational, social, neurocognitive, and counseling settings. The students learn the conduction, scoring, and interpretation of test results, as well as their implications. Experiments to understand concepts like learning, memory, and reaction time are also conducted.



11.1.6. Management Studies Computer Laboratory

The Department of Management Studies has a fully air-conditioned computer laboratory with 30 desktop computers, an all-in-one printer and an Internet facility. It provides access to various software packages for students for their skill development and data analysis. It houses portable projectors, laptops, sound amplifier, portable mics and portable white board for use by faculty and students during class presentations and events. Over the years it has become a technological hub for facilitating the department's academic pursuits.

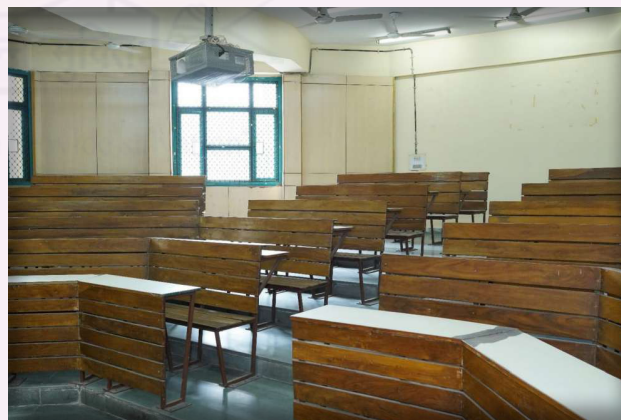


11.1.7. ICT Laboratory

The college features a dedicated ICT laboratory equipped with state-of-the-art systems capable of running sophisticated software like MATLAB and Mathematica. This facility is available for commerce and mathematics students who need to work on computers and statistics.

11.1.8. E-enabled Classrooms

The college boasts six spacious lecture theatres and 28 classrooms that are equipped with e-learning facilities. Nearly all college classrooms are e-enabled.



11.1.9. Amphitheatre

The campus has a beautiful and artistic amphitheatre featuring five pillars that symbolize the five elements – air, water, sky, earth, and fire. This venue plays host to a diverse range of student performances, competitions, and street plays.

11.1.10. College Auditorium

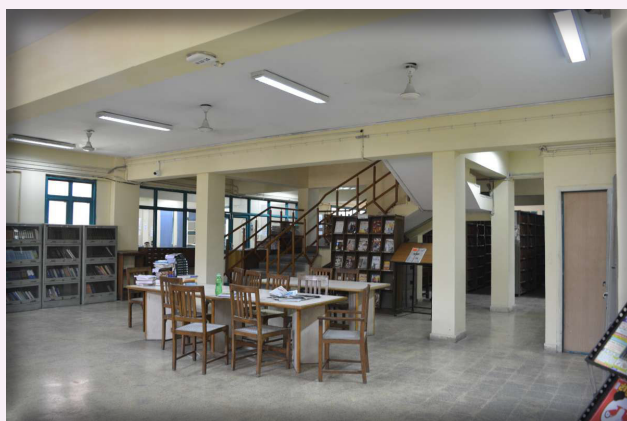

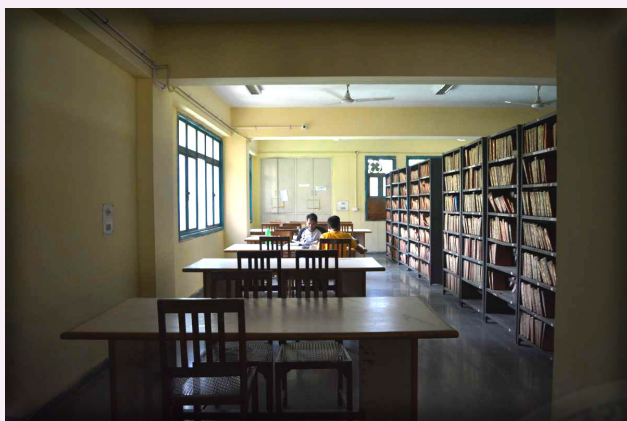
11.1.11. Library

The college maintains a well-stocked double-storey, spacious, fully automated library comprising a large reading room. It is a web-based Library. The library resources are available on NIC Cloud through e-Granthalaya software. The college has a membership of N-List – Database. Various e-resources (e-books and e-journals) provided by N List are available for Keshav Mahavidyalaya.



The library has various sections consisting of around 29984 books. It has a rich collection of textbooks, reference materials and encyclopedias of various fields. Many dailies, weeklies and periodicals of various subjects are being procured regularly. Around 34 Magazines and 15 Newspapers are subscribed by the library for the readers. The library has over 740 CDs and DVDs, given to various departments of the college.

Besides, it also provides the facility of accessing thousands of e-journals and research articles provided by the Delhi University Library System (DULS) through the Internet to staff members and students. The library has a separate Internet Lab for students and faculty. There are 32 CCTV



Cameras in the college library to keep a tight vigil. Keshav Mahavidyalaya Library has Braille Materials also for visually impaired users. The library has one Lez Air Camera Scanner along with a laptop with Lex Air VAD software as well as Braille Face and Devnagri Software.

11.1.12. Seminar Hall

A fully air-conditioned and well-equipped seminar hall hosts a variety of events throughout the year. It has a seating capacity of around 100 delegates and is equipped with an LCD Projector and an audio-conferencing public-address system.



11.1.13. Girls' Hostel

The college boasts a spacious and comfortable girls' hostel with a capacity of 78 students. The hostel provides safe and comfortable accommodation facilities to young girls aspiring for higher education at Keshav Mahavidyalaya, University of Delhi. The hostel is located on the college campus which is surrounded by beautiful lawns and sprawls in an area of 10 acres. Most of the rooms are on a twin/triple sharing basis. The hostel mess provides residents with fresh food. Medical services and

laundry services are available to the residents for their healthy and comfortable stay. WiFi-internet facility, telephone facility, an automatic sanitary napkin vending machine and many other facilities are also provided. A gymnasium, reading room and visitors area are available for residents within the hostel premises. A common room with a large LCD TV is available for the students to relax and have fun. The campus remains under CCTV



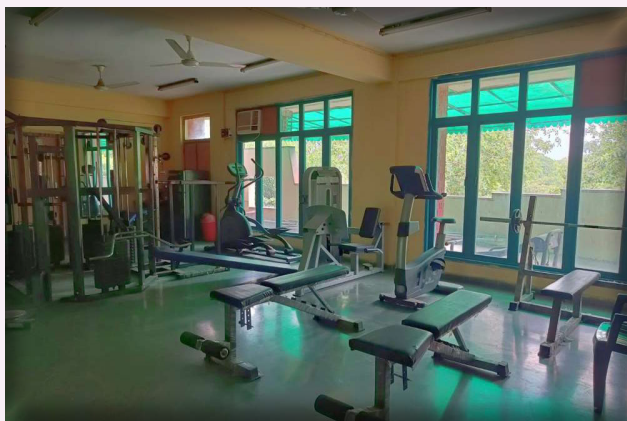
surveillance for 24 hours. The hostel warden who resides within the hostel premises extends care to the residents and makes them feel at home. A new wing in Girl's hostel for international students is operational with the accommodation of 6 foreign students. It has three rooms fully air-conditioned with attached bathrooms. It also has a common pantry and Gymnasium.

11.1.15. Cafeteria

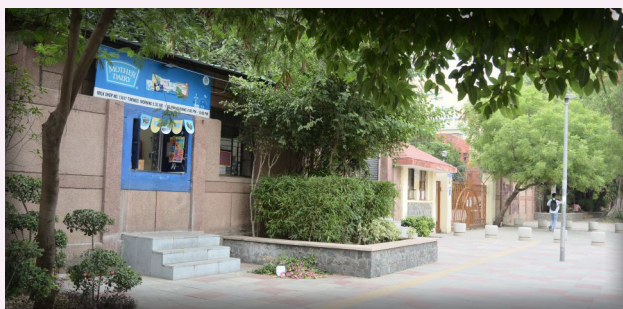
◆ Canteen

11.2. Student Development: Cells and Initiatives

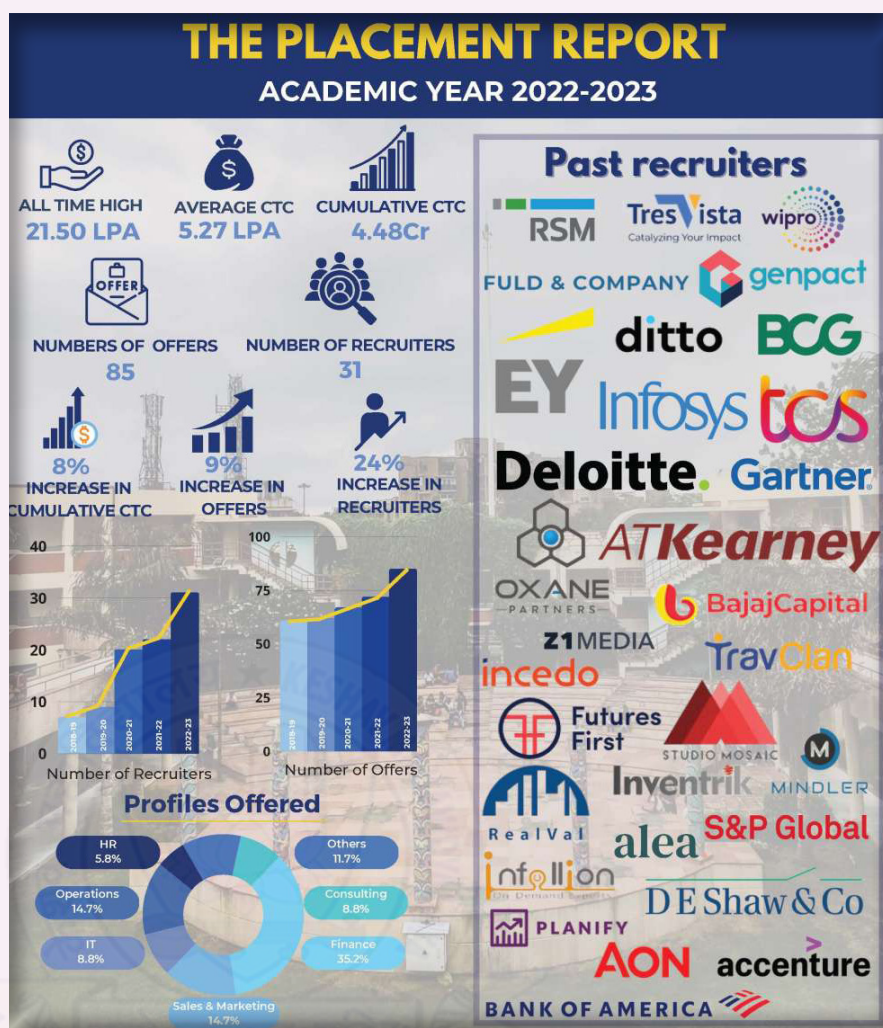
11.2.1. NSS

The college also has a National Service Scheme (NSS) Unit that aims to serve the nation and its citizens in all possible ways. With this goal and the motto, "Not Me, But You", the 2022-23 session focused on creating a greater impact on society through its projects Bhartiya, Muskan, Aarogya, and Parya-Karm followed by multiple events on the theme "Nashe se Azadi", mental health week, Clean India Campaign, and so on. Many drives were conducted like an envelope exchange drive, awareness drive, ribbon exchange drive, and an important session on Self Defense, a Legal Awareness session on Acid Attacks along with a series of events on Gender Sensitization, Happiness Day, Shaheed Diwas and Meteorological Day were conducted.



11.2.2. Placement Cell

The college has a well-organized and active placement cell that is committed to providing students with training and professional opportunities throughout their academic careers. The cell works around with the objective of facilitating contacts between firms, industrial establishments and graduates. Apart from organizing and coordinating recruitment drives, the cell also organizes training sessions, webinars and events for upskilling of the students like How to solve case studies, How to Ace Group Discussions and Personal Interviews, HR Conclave etc. The cell comprises of highly ambitious students from all courses who are shortlisted diligently at the



higher learning. In past years, many well-known companies such as BCG, PwC, D.E. Shaw, etc have visited our campus for placement drives. The all-time highest package of Rs. 21.5 lacs per annum



was offered by DE Shaw for the roles of Financial Research, HR Associate and Tech Associate and the average package for the academic year 2022-23 has been Rs. 5.3 lacs per annum and the cumulative package soared to 4.5 Cr with 70+ students placed so far this year.

11.2.3. ANUBHAV: The Psychology Internship Cell

Anubhav was established on 28th August 2018 with the aim to bridge the academia-industry

gap, by forming a liaison between students and various organizations. Students are helped to get

The Research Cell, Mimansa, was launched on 9th April 2022. The purpose was to provide a platform for the students for conducting and showcasing their research. As part of the launch event, an online session on Human-Computer Interaction was conducted. Workshops on SPSS and G-Power were conducted on the 18th of April 2023. Mimansa, in collaboration with the Research and Development Cell of the college, also conducted its first flagship event – PSYFORUM, a platform for intercollege paper-reading competition, on 29th March 2023.

Dwarika, the college Magazine, is published every year. The magazine provides the students with a powerful medium for their creativity and writing skills by contributing their articles, poetry and write-ups in English as well as in Hindi. It also highlights the academic, cultural and sports events of the college. Art and sketches by the students are also showcased in the magazine.

The Women Development Cell, in collaboration with the Global Hunt organization, organized an enriching seminar on Menstrual Health and Hygiene on 5th February 2022. The Women's Development Cell organized various events like an enriching open mic poetry on "Day to Self Care", a debate on "Women struggle: the stem gap", a legal awareness seminar on acid attacks etc. The inception of the events was marked by an energetic introduction of women who have achieved great heights in the past despite the gap and hardships faced.





11.2.7. Equal Opportunity Cell

The college is extremely sensitive to the problems faced by the differently abled, or of minority status, which stem from disabling environmental, economic and cultural barriers. To address these and other urgent issues concerning SC, ST, OBC and people with benchmark disabilities (PwBD), the Equal Opportunity Cell was set up by the University of Delhi on June 27, 2006, and a policy draft was released ensuring a barrier-free, equitable and accessible space to the PwBD, in the field of higher education. Our college has made all efforts for improvement in the overall infrastructure, and in the learning and teaching process for the differently abled academic community irrespective of visual, hearing, orthopaedic or other kinds of impairments.

11.2.8. PRAKRITI: The Environment Club

'PRAKRITI - Let it Grow' is the motto of the Environment Club of Keshav Mahavidyalaya. The club has always worked hard to promote the green culture - the cornerstone of Keshav Mahavidyalaya. The activities of the club attempt to impact the mindset of the students in both direct and indirect ways to appreciate and respect the environment. Recognizing the importance of the environment as a holistic entity to be respected and not merely used, the club activities include planting trees, recycling waste, and taking steps to control air/water pollution. It reiterates the idiom "TATTVAM ASI" (that thou art) i.e. man is a constituent of his environment. From this point of view, a herbal garden is being maintained. This helps students to learn about the benefits of growing herbs in a sustainable and environmentally responsible way. The Environment Club planned to create the multi-use garden to be more than

just a set of raised herbal plants. Rather it will be an open and welcoming space that encourages students to not just sow the seeds of herbs but also the seeds of togetherness and creativity. Further, the Club plans to make the space incredibly versatile with diverse



species structures. There are compost pits in the college gardens fulfilling the purpose of organic manure. In addition to this, as a part of eco-friendly practices, a compost machine was also installed at the college campus to ensure the use of natural manure produced from kitchen and garden waste. Also, the free distribution of saplings is undertaken by the garden committee to ensure tree plantation activity during the mass campaign.

11.2.9. ENACTUS: The Entrepreneurship Cell

Enactus, the Social Entrepreneurship Cell of our college is a branch of the internationally recognized student-run social entrepreneurship organization. It strives to build a better world by escalating enthusiastic students to become social entrepreneurs and giving them an opportunity to practically bridge the existing socio-economic disparities in a sustainable manner.



Enactus Keshav Mahavidyalaya is dedicated to uplifting the underprivileged through entrepreneurial ideas. With over 35 passionate student members, the cell creates sustainable solutions to address social challenges and make a positive impact in our community with the help of two of its flagship projects namely- Project Pehel and Project Sahaayta. "Pehel" symbolizes "Individualism & Determination." This endeavor known as Project Pehel strives to empower women and create lasting employment prospects for

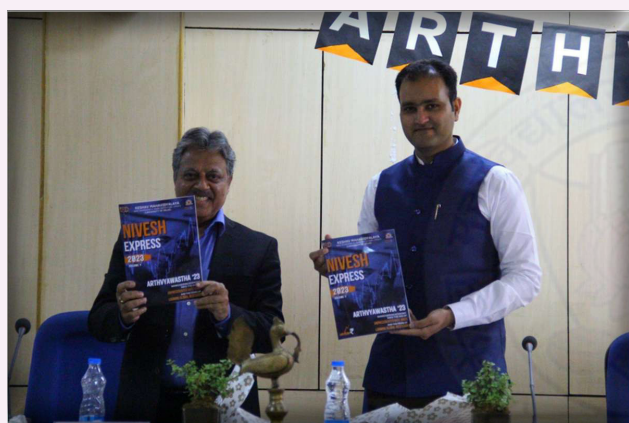

11.2.10. NIVESH: The Finance and Investment Cell

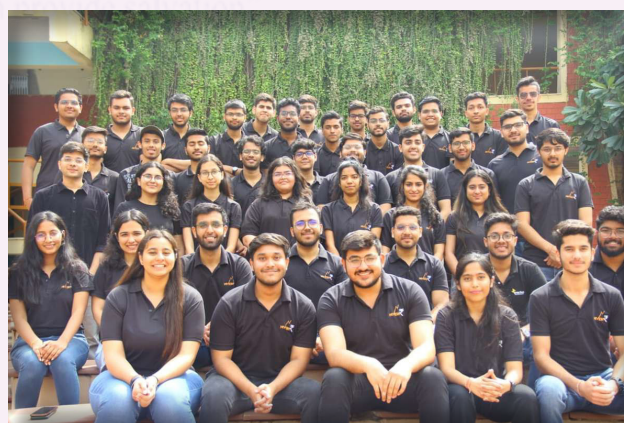

11.2.12. Keshav Mahavidyalaya Students' Union (KMVSU)

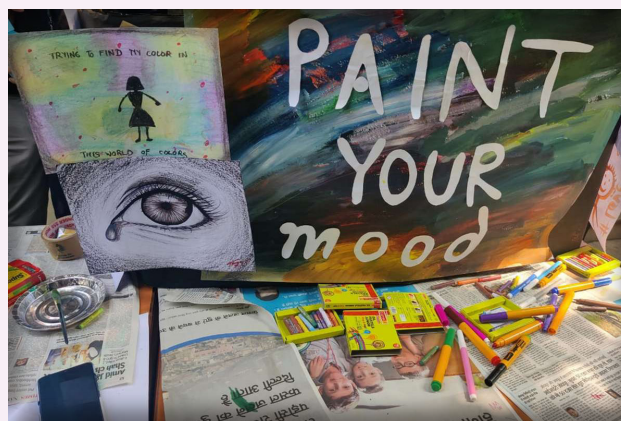

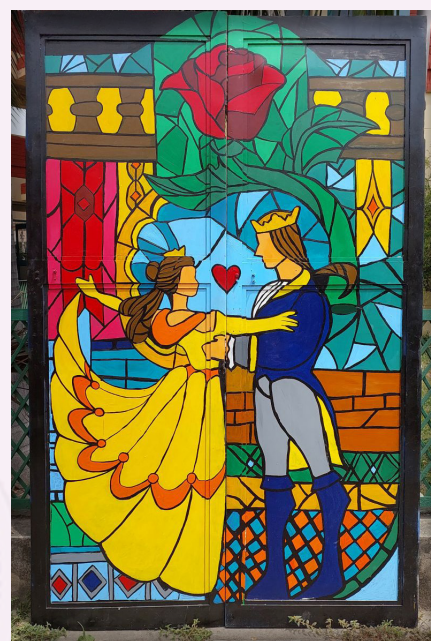
11.3.6. VAGMITA: The Poetry Society

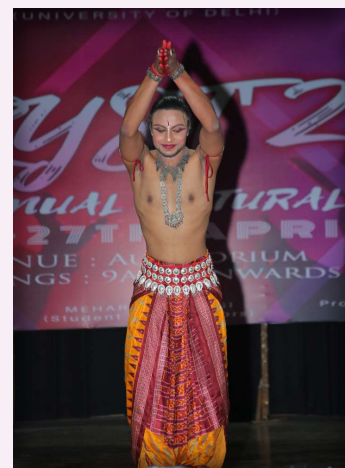
11.4.2. Freshers' Welcome

11.5. Departmental Societies

11.6. Other Facilities

11.6.1. SC/ST/OBC/Minorities Scholarships

The college is registered on NSP 2.0 portal and the District portal for student scholarships. NSP 2.0 portal wing helps the students in obtaining scholarships from numerous schemes run by the Government of India, Department of Higher Education. On the e-district portal, the Government of NCT of Delhi runs three Scholarships namely Post Matric Scholarship (SC)-CSSS, Post Matric Scholarship (OBC)-CSSS, and Merit Scholarship for students belonging to SC/ST/OBC/Minority category students studying in professional/technical Colleges /Institutes /Universities-State scheme.

11.6.2. Digital facilities

- ▶ The college campus is well connected through wired as well as wireless networks. Students have access to the internet with 100 Mbps connectivity by Fiber Optic/LAN cable backbone structure. The coverage of Wi-Fi is not only restricted to classrooms but also extends to all areas including laboratories, library, auditorium, amphitheatre and cafeteria. A separate Wi-Fi facility is also provided in the Girl's Hostel.
- ▶ Every student of the college is provided with an official email address created by the college on the college domain to communicate effectively with faculty members and to access study material available for their course on Keshav e-classrooms. It also enables the students to have an online identity of being a bonafide student of the college.
- ▶ Each student has also been provided with a user login account for the college website. Through this individual account, the students can log in through a secured password to access their attendance, internal assessment and other academic records.

11.6.3. Library Membership

Students need to furnish their fee receipt and college identity card to become a member of the library. Membership is yearly, and clearance needs to be taken at the end of every academic session. Library Reader Tickets (cards) are non-transferable.

11.6.4. Library Cards

- ▶ Students are given four (04) Library Reader's Tickets (Computer Science (Hons.) - 05) which can be used at the same time to facilitate readings. On Library Reader's Ticket No. 4 the book will be issued for one day only and on the rest of the Library Reader Tickets, books will be issued maximum for fifteen days.
- ▶ For books not returned on time, an overdue charge of Rs.5/- per day per book will be levied for the first week, Rs.10/- per day for the second week, Rs.25/- per day for the third week and in the fourth week if the book is not returned, the library membership of the student shall invite cancellation.
- ▶ Students have to show their College I-Card at the entry gate of the library, and while issuing the library books. No book will be issued without showing I-Card at the library counter.
- ▶ Students are not allowed to carry any bags into the library.
- ▶ In case of transfer of library tickets, the ticket of the original cardholder will be cancelled.
- ▶ In case, the tearing of pages from any book is reported, strict disciplinary action will be taken.
- ▶ If a Reader/member loses his/her library ticket, a duplicate library ticket will be issued to him/her in the next academic year to avoid any kind of misuse of the library tickets.
- ▶ A fine of Rs.100/- per card shall be charged for the lost Reader's Ticket. A fine of Rs.50/- towards the issue of a Duplicate Card will be charged.
- ▶ In case of repeated loss of Reader's Tickets, duplicate cards shall be considered only after prior approval of the Principal.
- ▶ Books issued on loan can be asked to return at any time without assigning any reason thereof.
- ▶ The Library Membership Form is to be submitted after the admission is secured.

11.6.5. College Identity Card

Every student will be issued an identity card which he/she should always carry and produce on demand. Failure to do so is liable for disciplinary action. I-card must be returned when the student leaves the college. Loss of I-card should be reported to the office immediately.

11.6.6. Fee Concession Committee

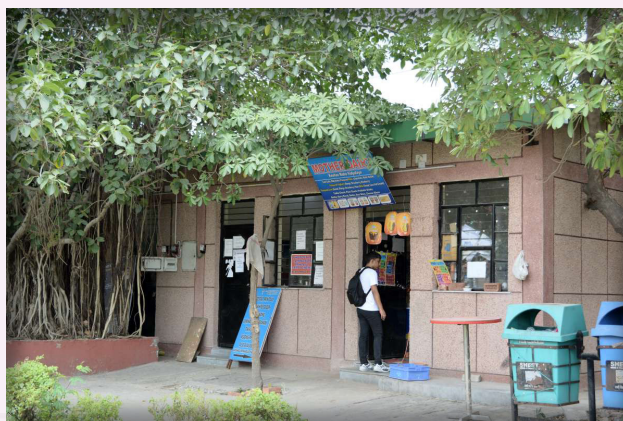
The college provides financial assistance to students hailing from economically weaker sections, either through waiving their college fees (excluding exam fees) or in the form of a books grant. The college also gives fee concessions to deserving students. All the students can apply for the same to the fee concession committee through the Principal's office at the beginning of the session.

11.6.7. Mentor-Mentee Groups

The college is adopting a Mentor-Mentee practice in which students from different years are associated with faculty members. They keep connected in groups for any kind of support or guidance. Mentor-mentee meetings are held regularly and students are encouraged to share their academic or personal problems with their mentors. These interactions keep faculty in constant touch with students, iron out academic and personal issues, and stimulate overall personality development.

11.6.8. Photocopier Machine

The college has a photocopying facility at reasonable prices for students, available adjacent to the Mother Dairy booth.



11.6.9. ATM

An ATM machine is installed on the college campus by Canara Bank for providing easy access to banking services for the college students and staff. The college also provides the facility for digital transactions to the students.

11.6.10. Bus Pass

DTC provides the facility of concessional bus passes for college students which are available on demand, college facilitates the students by providing arrangements for the verification of the DTC Bus Pass form. The facility for verification for rail concession is available to the students at the college office for visiting their parents in their home town (to and fro) during vacations only.



12. Discipline

Ragging in any forms is strictly prohibited. The complaints of ragging shall be dealt under regulations 2009 notified on DU website: www.du.ac.in. In addition to the provisions of Ordinance XV-C, all other measures decided upon by the Honorable Supreme Court of India, Ministry of HRD and the UGC would be binding on the University, Colleges.

Anti-Ragging and Discipline Related Guidelines

1. Students are responsible for their conduct within the college premises and are prohibited from doing anything in the College campus, which will amount to a breach of discipline or interference in the smooth functioning of the college.
2. A student shall be liable to disciplinary action for any act of indiscipline. Disciplinary action may involve warning and/or suspension from classes, from the examinations, from the college library or even from the college. All the rules and norms as provided in Ordinance XV (B), XV (C) and XV (D) of the "Rules of Discipline of the University of Delhi" would be strictly adhered to in case of any act of indiscipline.
3. Students shall conduct themselves in a civil and dignified manner, and desist from offensive behaviour towards any section of the college community. Uncivilized behaviour and/or language shall be sternly dealt with.
4. Students shall maintain silence and decorum in class rooms and corridors, and desist from disorderly behaviour. Verbal abuses will also be considered as violation of the discipline.
5. Use of mobile phones during the class is strictly prohibited.
6. Playing any sports in the college corridors is strictly prohibited.
7. Smoking in the college premises is an offence and is strictly prohibited under the law.
8. Possession or the consumption of alcohol/ drug or any other addictive/illegal material is strictly prohibited in the college premises and will lead to serious disciplinary action including termination from the college.
9. Ragging in any form is strictly prohibited and is a punishable offense. Anyone involved in such cases will be dealt strictly with as per the GUC Regulations 2009 as amended from time



10. Students shall take proper care of the college assets, including furniture and fixtures. They must not cause any damage to the college property. It could attract disciplinary action against them.
11. Students are notified to not litter, lay or throw any kind of garbage in and around the campus.
12. A designated parking space is provided for all students to park their vehicles. No vehicle would be allowed to be parked in any other part of the college premises.
13. Students cannot form any society/club in the college without the prior permission of the Principal, nor shall any person can be invited to address a meeting in the college without the formal consent of the Principal.
14. The students are required to follow all disciplinary rules/regulations as formed by University of Delhi from time to time.
15. The college has a zero-tolerance to ragging and very strict anti-ragging policy. Kindly go through the document provided in the following link:

13. Right To Information (RTI) Act

1. An application for obtaining information under the Right to Information Act, 2005 can be addressed to the Public Information Officer. Placement
2. The prescribed fee for filling the application i.e. ₹10 and other fees for obtaining the information may be deposited by way of cash against proper receipt to the Cashier, Accounts department of the college or by way of bank demand draft or banker's cheque or Indian postal order payable to the Principal, Keshav Mahavidyalaya, Delhi.
3. An appeal can be preferred before the First Appellate Authority against the decision of the Public Information Officer of the College.

17. Annexures

17.1. Annexure I: Ordinance XV-B: Maintenance of Discipline among students of the University

1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
3. Without prejudice to the generality of power to enforce discipline under the Ordinance, the following shall amount to acts of gross indiscipline:
 - a. Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/ Department and against any student within the University of Delhi;
 - b. Carrying of /or threat of use of any weapons;
 - c. Any violation of the provisions of the Civil Rights Protection act, 1976;
 - d. Violation of the status, dignity and honour of students, belonging to the scheduled castes and tribes;
 - e. Any practice-whether verbal or otherwise derogatory of women;
 - f. Any attempt at bribing or corruption in any manner;
 - g. Willful destruction of institutional property;
 - h. Creating ill-will or intolerance on religious or communal grounds;
 - i. Causing disruption in any manner of academic functioning of the University system;
 - j. Ragging as per Ordinance XV- C.
4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor may in the exercise of his/her power aforesaid:
 - a. Order or direct that any student or students be expelled; or
 - b. Any student or students be, for a stated period, rusticated; or
 - c. Any student or students be not for a stated period admitted to a course or courses of study in a college, department or institution of the University; or
 - d. Any student or students be fined a sum of rupees that may be specified; or
 - e. Any student or students be debarred from taking a University or college or departmental examination or examinations for one or more years; or

- f. That the result of the student or students concerned – in the examinations in which he/she or they have appeared be canceled.
5. The Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads Teaching Departments in the University, the Principal, School of Correspondence Courses and Continuing Education and Librarian shall have the authority, to exercise all such disciplinary powers over students in their respective colleges, Institutions, Faculties and Teaching Departments in the University as may be necessary for the proper conduct of the institution, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to, such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
6. With our prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of the Halls, Deans of Faculties, Heads Teaching Departments in the University. Each student shall be expected to provide himself/herself with a copy of these rules.
7. At the time of admissions, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the acts, the Statutes, the Ordinances and the rules that have been framed there under by the University.

17.2. Annexure II: Ordinance XV-C: Prohibition of and Punishment of Ragging

1. Ragging in any form is strictly prohibited, within the premises of College/Department of Institution and any part of Delhi University system as well as on public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under the Ordinance.
3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts of practices which
- Involve physical assault or threat or use of physical force;
 - Violate the status, dignity and honour of women students;
 - Violate the status, dignity and honour of students belonging to the scheduled castes and tribes;
 - Expose students to ridicule and contempt and affect their self-esteem;
 - Entail verbal abuse and aggression, indecent gestures and obscene behaviour.
4. The Principal of a College, the Head of Department or an institution, the authorities of College

or University Hostels or Halls or Residence shall take immediate action on any information of the occurrence of ragging.

5. No withstanding anything in Clause (4) above, the Proctor may sue motto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advice the Vice-Chancellor accordingly.
8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in clause 3 (a), (b) and (c), the Vice- Chancellor shall direct or order rustication of a student or students for a specific number of years.
10. The Vice-Chancellor may in other cases of ragging order or direct that a student or students be expelled or be not for a stated period admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
11. In case where students who have obtained degrees or diplomas of Delhi University are found guilty under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diploma conferred by the University.
12. For the purpose of this Ordinance, abetment to ragging will also amount to ragging.
13. All institutions within the Delhi University system shall be obligated to carry out instructions/ directions issued under the Ordinance and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

For NOTE:

"Order of the Vice-Chancellor in pursuance of ordinance XV-(c) : Where incident (s) of ragging are reported to the Vice-Chancellor by any authority under this ordinance, the student(s) involved in ragging shall be expelled for a specified term designated in the order; non-students involved in reports of ragging will be proceeded with under the Criminal Law of India, they will also be rendered ineligible for a period of 5 years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note will be given post decisional hearing, with strict adherence to the rules of natural justice."

17.3. Annexure III: Ordinance XV-D/ The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAW AND JUSTICE)

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

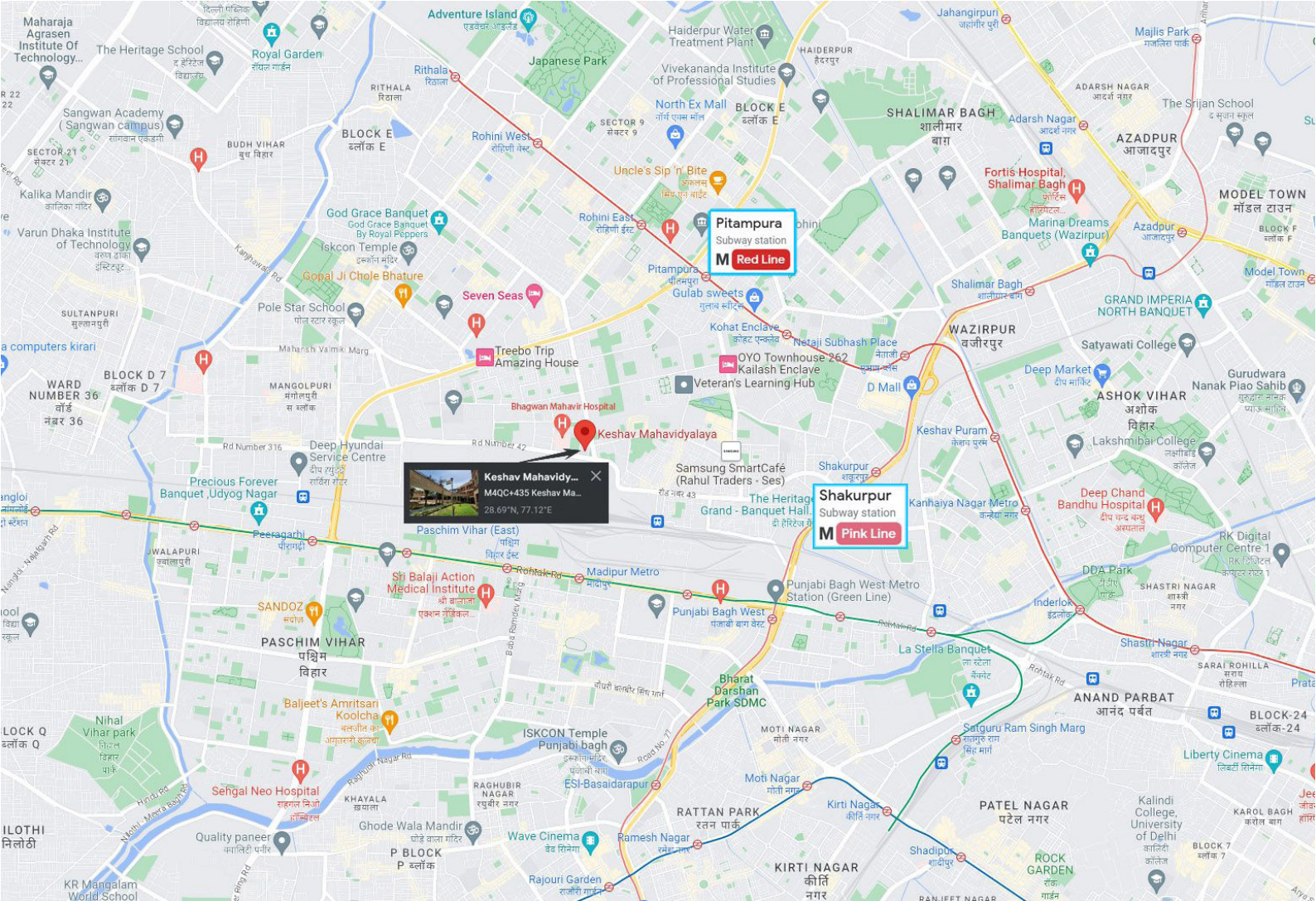
WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment;

AND WHEREAS the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all forms of discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India.

AND WHEREAS it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace.
