The GB also granted permission an annual increment of Rs. 1000/- per year to Warden.
- 7. A Budget of Rs. 1,39,000/- submitted by Department of Management Studies for organizing CEO'17 event on 11th October, 2017 was reported, recorded and approved.
- 8. The Governing Body permitted an additional budget of Rs. 50,000/- from appropriate college fund to Department of Electronics of college for organizing a 2 days' National Level Faculty Development Programme on "Embedded System Design Using AVR and Digital System Design Using Programmable Logic Devices" on 1st November, 2017.
