#### GUIDELINES FOR ADMISSION TO VARIOUS UNDERGRADUATE COURSES

#### I. Guidelines for Admission

#### 1.1 Qualifying Examinations

Qualifying examinations for the purpose of admission to the first year of undergraduate courses offered by the University shall be Senior Secondary School Certificate Examination (Class12th) of the Central Board of Secondary Education or an examination recognized as equivalent thereto. Candidate seeking admission to the courses offered by the college should have passed the qualifying examination obtaining minimum marks as specified for each of the courses in subsequent sections.

#### 1.2 Age Requirement

There is no minimum age bar for admission to undergraduate courses in the University colleges except in professional courses where regulatory body prescribes minimum age requirement (such as MCI, AICTE etc.) (Ordinance I). Gap Year/s would be no bar for purposes of admission to the Undergraduate Courses.

#### 1.3 Equivalence Criteria

The applications for admission to the undergraduate courses in the Colleges in respect of candidates belonging to the Examining bodies of Boards / Universities recognized / accredited by the Association of Indian University / University Grants Commission Ministry of Human Resource Development shall be considered by the College in terms of the recommendations as circulated in the University circular letter of 13-1-2005.

- 1.4 All the candidates of categories (General/OBC/SC/ST/PWD) interested in seeking admission in the courses offered by the college must have filled the centralised University pre-admission form either online or offline. This is mandatory for all candidates. There will be no pre-admission at the college level.
- **1.5** The college provides advantage (upto 3% relaxation in marks) to girls students in certain courses that shall be notified along with the cut-off.
- 1.6 The cut-offs notified by the university shall be displayed on the University Web-site (<u>http://du.ac.in</u>), college website (<u>www.keshav.du.ac.in</u>) and college notice board as per the admission schedule.
- **1.7** The college shall admit all the candidates who have percentage that meet the announced cut-off criteria. No first-come-first served policy is permitted.
- **1.8** After declaration of the cut off lists by the University, the candidate will need to report to the college for admission within the stipulated period. At this stage, the candidate would be required to fill the college admission form and the University

enrolment form. The candidate would then get his/her documents verified, submit the same to the college and pay the admission fees. For availing the benefit of reservation in any category, the candidate must submit the relevant certificate issued by respective issuing authority.

**1.9** a. The candidates who could not take admission in a cut-off list could be considered for admission in the immediate next list only on the last date of admission provided seats are available in the college/course.

b. For Boards, like IB, whose results are declared late, candidates may be considered in whichever cut-off list their results are declared subject to availability of seats, provided the candidate had completed pre-registration process.

- 1.10 The colleges shall retain the certificates of the candidate during the admission process and shall promptly return the documents in case, he/she cancels his admission or has to appear in counselling of any other university/ institute or in order to move to another college on declaration of a subsequent cut off lists.
- 1.11 No student will be allowed to take admission in two courses/colleges simultaneously. In case a candidate is found admitted in two courses/colleges simultaneously, the admission in all courses/colleges will be cancelled.
- **1.12** The college shall follow the University guidelines with respect to gap year policy: Gap year(s) would be no bar for purposes of admission to the undergraduate courses.
- 1.13 For admission under the reserved categories of Children/Widows of eligible Armed Forces Personnel/ Kashmiri Migrants, the admission process shall continue to be centralized and conducted at the University level by the office of Joint Registrar (Academic). The schedule of registration/admission for admission under these categories shall be notified on the University's Website www.du.ac.in.
- 1.14 All those candidates who are covered under any of the categories of reservation for children of Armed Forces Personnel/Kashmiri Migrants must have registered separately online/ offline if they wish to be considered for any other category [Gen/OBC/SC/ST/PwD).
- 1.15 For the Bachelor of Management Studies (BMS) course, the admissions are done through entrance exam, and hence separate procedures as notified on University website from time to time shall apply.
- **1.16** The procedure for calculation of Best of Four percentages (wherein admission is done on the basis of Best of Four) is outlined in section 3.
- **1.17** The admission to the Sports and ECA (Extra Curricular Activities) categories shall be on the basis of University guidelines.
- 1.18 The College Grievance Committee shall be available in the College throughout the admission process. The details of the Grievance Committee members shall be put on the College Website and on College Notice Board.
- 1.19 The data of candidates admitted in college shall be made available on college website.
- 1.20 Last date of admission for undergraduate courses will be 14 August 2015.
- 1.21 The Special Scholarship Scheme of the Government of India for creation of 2 supernumerary seats for the students of Jammu & Kashmir shall be implemented for

all regular three year undergraduate courses. Admission under this Scheme shall be made directly by the college on the basis of the Provisional Admission Slips issued by the All India Council of Technical Education (AICTE) subject to verification of the required documents.

- 1.22 Certificate of physical disability issued by chief medical officer/civil surgeon of district or any government hospital authorised to give such certificate under the provisions of PwD Act 1995 will be considered for admission. In case of any query you may refer to http://www.ccdisabilities.nic.in
- 1.23 The college shall prepare a separate cut off list for Persons with Disabilities and ensure that maximum students are accommodated as per their requirement of courses.
- 1.24 The merit list for the general category seats will comprise of all the candidates in the order of merit .No one will be excluded from the same. In other words, it will also include SC / ST / OBC candidates if they come in general merit. The candidate cannot be excluded from the general category merit list just because he belongs to SC/ST/OBC. Such a candidate is entitled to be considered under the general category, as well as under the reserved category. Admission to open category seats will be strictly in the order of merit without excluding SC/ST/OBC candidate.
- **1.25** The University reserves the right to initiate changes in the courses of study of the undergraduate courses and the same shall apply in the college.
- **1.26** The college is having 75 seated girls' hostel admission guidelines for which are provided in Annexure ii.
- **1.27** The provisions of ordinances VII (2) shall be applicable as per university guidelines.

#### II. Reservations and Relaxation/Concession

#### 2.1 Scheduled Caste/Scheduled tribes

- 22½ % of the total numbers of seats is reserved for candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7½% for Scheduled Tribes, interchangeable, if necessary).
- It is a statutory obligation on the part of College to fill all seats reserved for Scheduled Caste/Scheduled Tribe candidates.
- The College shall not refuse admission to any SC/ST candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language would be removed, remedial classes for which may be arranged by utilizing grants that are available from University Grants Commission.
- Relaxation to the extent of 5% in the minimum marks will be given to the candidates belonging to Scheduled Caste and Scheduled Tribes to determine their eligibility and merit for admission to the course concerned.
- In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill up all the reserved seats.

Note: SC/ST students who get admission under open merit will not be included in the reserved quota i.e. 22.5%.

#### 2.2 Other Backward Classes (OBC)

- 27% seats will be reserved for the candidates belonging to OBC.
- At the time of giving admission to an OBC candidate, the College will ensure that the caste is included in the Central List of OBC. The certificate must mention non-creamy layer status of the candidate.
- The OBC candidates shall be given a relaxation of 10% in the minimum eligibility marks of the said course prescribed for General Category candidates.
- It is a statutory obligation on the part of College to fill all seats reserved for OBC candidates.
- The Colleges shall not refuse admission to any OBC candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be removed, remedial classes for which may be arranged by utilizing grants that are available from University Grants Commission.
- If the seats meant for OBC remain vacant after arriving at the minimum eligibility, the same may be converted and filled up by other eligible candidates.

#### 2.3 Persons with Disabilities (PwD) (Supernumerary Seats)

Three percent (3%) seats in all undergraduate courses will be reserved for candidates having minimum 40% disabilities.

Concessional/Waiver of fees in respect of Persons with Disabilities (PwD)

- 1. The students with physical disabilities pursuing various courses shall be exempted from payment of fees, including examination fee and other University fees, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee.
- 2. In pursuance of the Executive Council Resolution No. 50 dated 03.11.2012, it is notified that the students with physical disabilities residing in Hostel are exempted from payment of all hostel fees and charges except 50% mess fee and refundable caution fee.

It is clarified further that the PwD students who are getting fellowships / financial assistance shall be exempted from payment of fees / charges / mess fees subject to the following conditions:

Value of Fellowship	Exemption of Fees Waiver etc
Up to Rs. 3000/- per month	Fees waiver + 50% Mess Subsidy
Rs. 3001 to 8000 per month	Fees waiver but no Mess Subsidy
Rs. 8001 and above per month	No fees waiver and no Hostel Subsidy

All Eligible SC/ST, OBC, PwD students who are admitted to the college should submit their scholarship form by February for processing scholarship to SC/ST, OBC, PwD each year.

## **2.4 Children/Widows of the Eligible Armed Forces Personnel (CW Category)** (Supernumerary Seats)

5% of the seats in each course have to be offered to the Children / Widows of Officers and Men of the Armed Forces including Para-Military Personnel, in the order of preference given below. Such candidates must have got their names registered at University of Delhi.

- i. Widows / Wards of Defence personnel killed in action;
- ii. Wards of serving personnel and ex-servicemen disabled in action;
- iii. Widows / Wards of Defence personnel who died in peace time with death attributable to military service;
- iv. Wards of Defence personnel disabled in peace time with disability attributable to military service;
- v. Wards of Ex-servicemen personnel and serving personnel including police personnel who are the recipient of Gallantry Awards (Above categories are also applicable for Para Military Personnel)

In order to become eligible for the above concessions, the Children / Widows of the Officers and Jawans etc. will be required to submit the certificate of educational concessions (in original) from anyone of the following authorities:

- Secretary, Kendriya Sainik Board, Delhi
- Secretary, Rajya / Zila Sainik Board
- Officer-in-Charge, Record Office
- First-Class Stipendiary Magistrate
- Ministry of Home Affairs (For police personnel in receipt of Gallantry Award).

A concession of 5% marks in the minimum eligibility requirements prescribed by the University for admission to general category candidates to various courses will be extended to such candidates.

#### 2.5 Kashmiri Migrants (Supernumerary Seats)

The wards of Kashmiri Migrants must have registered centrally with the University for admission to various undergraduate courses in different streams (i) Arts/Humanities (ii) Commerce (iii) Sciences/Applied Sciences/Mathematical Sciences, except the BMS course where admissions are made on the basis of Entrance test. The allotment of seats to the courses shall be made on the basis of preference-cum-merit, not more than three seats in the college, one seat in one stream.

- The allotment of seats to the courses will be made on the basis of preference-cum-merit, not more than three seats in the college, one seat in one stream.
- Candidates will have to fulfil the minimum eligibility requirements prescribed by the University for admission to various courses.

- A concession of 5% marks in the minimum eligibility requirements prescribed by the University for admission of general category candidates to various courses will be extended to the candidates. (The candidates selected under special Scholarship Scheme for J&K will be admitted directly to college).
- A concession of maximum 10% in the last cut-off marks fixed for general category candidates shall be extended to such candidates.

The candidates applying under the categories of 'Reservation for children of War Widows / Kashmiri Migrants' must register separately online/offline through common preadmission form if they wish to be considered under any other categories (Gen. / OBC / SC / ST / PwD)

#### 2.6 Foreign Students (Supernumerary Seats)

All foreign students, including those who have completed their schooling from an Indian Board may be treated as Foreign Students for the purpose of their registration / admission and they may be considered for admission under 5% quota prescribed for the foreign students in each course.

The foreign candidates seeking admission to undergraduate Courses should apply to Deputy Dean Foreign Students), Conference Centre, University of Delhi-110007. Email: <u>dydean\_fs@du.ac.in</u>

#### 2.7 Sports/ ECA (Supernumerary Seats)

The existing provision of not more than 5% sports / ECA quota (subject- wise) be continued. The College-would decide the actual number of seats to be filled on sports basis (not more than 5%) keeping in view the facilities available, requirement of the College and other relevant factors.

The guidelines for Admissions under sports / ECA categories will be carried in accordance with the guidelines notified by the University from time to time. (refer to Annexure 1)

#### 2.8 Special Scholarship Scheme (Supernumerary Seats)

The Special Scholarship Scheme of the Government of India for creation of 2 supernumerary seats for the students of Jammu & Kashmir shall be implemented for all regular three year undergraduate courses. Admission under this Scheme shall be made directly by the college on the basis of the Provisional Admission Slips issued by the All India Council of Technical Education (AICTE) subject to verification of the required documents.

#### 2.9 Foreign students(Supernumerary Seats)

All foreign students, including those who have completed their schooling from an Indian Board may be treated as Foreign Students for the purpose of their registration / admission in College and they may be considered for admission under 5% quota prescribed for the foreign students.

### III. ACADEMIC SUBJECTS AND PROCEDURE FOR CALCULATING BEST OF FOUR PERCENTAGE

(For Courses wherein admission is done on the basis of Best of Four)

# 3.1 Procedure for calculation of 'Best of Four' subjects percentage for Honours Courses (For Admission to Arts/Humanities Courses):

- a. One Language (Core/Elective/Functional)
- b. The subject in which admission is sought (If a candidate does not include concerned subject whether studied or not in Best of Four in which he/she is seeking admission in the honours course, then a disadvantage of 2.5% may be imposed on the calculated Best of Four percentage).
- c. Any two other academic/elective subjects as per List A. (If a candidate doesn't include the subjects given in List A in Best of Four, then a disadvantage of 2.5% in Best of Four for each subject may be imposed).

#### List A

The following Discipline subjects offered by the University of Delhi for admission to undergraduate courses must be treated as Academic/Elective subjects for the purpose of undergraduate admissions. All other subjects offered by different boards may be treated as non-elective. All the Discipline subjects must have at least a 70% component of theory exams (theory exam does not include internal assessment/continuous evaluation etc.) in the qualifying exam for the purpose of being treated as academic/elective subject.

5. The subject 'Informatics Practices' will be equivalent to Computer Science for admission to B.Sc. (Hons.) Computer Science only.

6. The candidates must have studied and passed Mathematics at the qualifying exam for admission to Honours in Commerce.

7. University may define any other relevant subjects as academic/elective for a particular Honours course.

#### 3.2 Admission to Science Courses

The Basis of Selection for Mathematical Sciences/Science courses remains unchanged. However, the subjects to be included for Basis of Selection (PCM/PCB/PCMB) must have at least 70% component of theory exams (theory exam does not include internal assessment/continuous evaluation etc.) in the qualifying exam otherwise a disadvantage of 10% of the maximum marks may be levied on each such subject.

## V. RECHECKING/REVALUATION AND COMPARTMENT CASES

The college shall consider admission of those candidates whose marks get increased in the process of rechecking/ revaluation by their respective boards within the prescribed period of admission provided that they fulfil the other eligibility conditions laid down for admission.

## VI. CANCELLATION OF ADMISSION & FEE REFUND

A student who wishes to get his/her admission cancelled must apply in writing on a form available for this purpose from College Office/Departmental Admission Incharge/Central Admission Committee. The fee slip must be countersigned by his/her parents/guardians. The candidate must get his/her form forwarded by Department Admission Incharge and recommended by Central Admission Committee. Then the form will be submitted to the college office. Refund of fees will be made as per Delhi University rules. Candidates, who fail to pass at the Compartmental examination by 31<sup>st</sup> August, 2015 shall not be entitled to continue on rolls and their provisional admission will be cancelled without any further reference to them.

## COLLEGE PROFILE

Keshav Mahavidyalaya is one of the most preferred and the best off Campus Colleges. It was established by the Govt. of NCT of Delhi in 1994. The foundation stone of the campus was ceremoniously laid by Ms. Sheila Dikshit, the Honourable Chief Minister, Govt. of NCT Delhi on March 23, 2003. Honourable Lt. Governor of Delhi Mr. B.L. Joshi inaugurated the building on 27 Nov. 2005.

The College provides internet facility to its faculty and to students in their respective labs through the University of Delhi, Computer Centre via intranet. All the labs in the College have access to e-journals subscribed by the University of Delhi through its intranet. The University of Delhi has facilitated the College campus with Wi-Fi connectivity that is vital for academic and research activity.



The College boasts of a spacious and comfortable Girls' Hostel with a capacity of 75 Students on twin sharing basis. Equipped with all basic and necessary facilities, the hostel provides its residents many opportunities to fulfill their academic, cultural, and social needs.

The college promotes organizing of Seminars, Workshops and Lectures in every field of Academics, Environmental and Health issues, Social service and other co-curricular activities. With a view to provide help to economically weak or meritorious students the college also provides scholarships and fee concession facilities.

## INFRASTRUCTURE

#### LABORATORIES

At Keshav Mahavidyalaya we believe in hands-on experience for the students. We believe that theoretical knowledge is insufficient and incomplete. For this purpose, well equipped laboratories have been set up in all the relevant courses.

#### Physics Lab

The college has two Physics Labs, equipped with the latest and sophisticated instruments, which are used for practical work related to mechanics, optics, heat and electrical circuits. Separate air-conditioned dark rooms are also available for performing experiments related to optics and ballistic galvanometer. The labs are continuously upgraded to ensure that the students are equipped with the latest skills. The facilities in the lab include

- Hall Effect set up
- Michelson's interferometer
- Ultrasonic grating set up
- Set up for elliptically polarized light

- He- Ne laser interfacing facilities.
- Computer simulation facilities
- CRO & TV trainer kits
- Set up for PE Hysteresis













#### **Electronics Lab**

These labs are used to perform experiments based on Analog electronics, Digital circuits and Systems, Instrumentation, Communication and Signal Processing and Micro-processor Applications. Students develop a working knowledge of various integrated circuit families, circuit designing, ROM, EPROM, and RAM. These labs are equipped with the latest 8085 and 8086 trainer kits.

#### Chemistry and Biology Labs

College has two very well equipped laboratories for Organic, Inorganic, Physical, Analytical and Biological Chemistry experiments. These labs are well furnished and have the following modern instruments: UV-Visible Spectrophotometer, Flame photometer, Vertical laminar flow, Water Deionizer, Digital pH meters, Digital potentiometers, Digital Conductivity meters for conductivity and TDS measurements, Digital Colorimeters, Digital Electronic balances, Autoclave, Centrifuge machine, Electrophoresis machine and latest Microscopes with projection system etc. The biology labs are well equipped too. Computer facility is also available in both labs for students use.

#### **Computer Lab**

The Computer wing has three spacious computer labs equipped with the state-of-the-art facilities. All the systems are of latest configuration. The labs can accommodate approximately 90 systems apart from servers. There is a separate UPS room. The lab has a wireless LAN using Wi-Fi Routers. It also provides multimedia and graphics facilities and is equipped with an OHP, LCD Projector, and Scanner.

#### **BBS/BMS** Computer Lab

A fully Air conditioned Lab with internet facility and access to software like SPSS, Capitaline, ProjectLibre is also there for BBS Students.

#### ICT Lab

The College has dedicated ICT lab which have high end systems to run sophisticated software such as MATLAB, Mathematica etc. for commerce and mathematics student to work on computer and statistics.

#### Psychology Lab

The Psychology lab of the college is well equipped with the latest Psychological tests and instruments such as 3 Digital Reaction Time Apparatus, 3 Mirror Drawing Apparatus,4 Muller Lyer Apparatus with Stand,3 Digital Arm Type Blood Pressure Monitor, 3 Digital Thermometer, 2 Memory Drums. Every year, new instruments and tests are added to give a wide exposure to students. The lab has a wide range of standardized Psychometric Tests applicable in clinical, organizational, social, neurocognitive and councling settings. A total of 36 Psychometric Tests and Scales are available in the Laboratory.

#### E-enabled Classrooms

The college has six big lecture theatres and 28 classrooms equipped with e-learning facility. Almost all classrooms in the college are e-enabled.

#### Amphitheatre



The campus has a beautiful amphitheatre with five pillars symbolizing the five elements – air, water, sky, earth and fire. It is a host to a variety of performances, competitions, street plays etc. by students. It is also the hot favourite with students as it has borne witness to performers like Juggy D and Benny Dayal.

#### Seminar Hall

A fully air-conditioned and well-equipped seminar hall is used to host a variety of events throughout the year. The seminar room has a seating capacity of around 100 delegates and is equipped with an LCD Projector, Interactive Board and audio conferencing public address system.



#### **Girls Hostel**



The college boasts of a spacious and comfortable Girls' Hostel with a capacity of 75 students. It has completed a successful one and a half years with its 43 residents. The hostel provides safe and comfortable accommodation facilities to young girls aspiring for higher education at Keshav Mahavidyalaya, University of Delhi. The Hostel is located in the college campus surrounded by beautiful lawns and sprawls in an area of 10 acres. Most of the rooms are on twin-sharing basis. A common room with a large LCD TV is available for the students. It has Principal's and Warden's residence within its premises.

#### Auditorium

The college has a state-of-the-art auditorium with a seating capacity of 800 persons (Area~2569sq m). It is fully air conditioned, built with best acoustics, and high end light and sound facilities. It has two green-rooms, one for boys and the other for girls. It has been the centre for all cultural and academic activities of the college.



The auditorium, since its inauguration, has borne testimony to the talented performances of renowned maestros including Ms. Shovana Narayan, Sh. Shiv Kumar Sharma, Smt. S. Kanaka, Warsi Brothers, and Mr. Shashank Subramanyam. The last year was no exception with stalwarts like Ronu Mukherjee and Haji Aslam Sabri gracing the stage. Recently the college has organised Santoor performance by renowned Santoor artist Pandit Satish Vyas which was accompanied by Tabla performance by Ustad Akram Khan. It has also witnessed an array of eminent speakers from diverse fields of academics, management, IT industry, governance, and theatre who have shared priceless thoughts with the staff and students of the college.


It also serves as a platform to boost the confidence of the college students to come up and show their talent as dancers, singers, actors and display their capabilities as future professionals, managers and event organizers. It is also the hub for major college events like the Orientation Program, the Annual Day, and the College Farewell.

#### Library

The college maintains a well-stocked, fully computerized library comprising of a large reading room. The library has large number of books with new books and editions added every year. It has a rich collection of text, reference materials and encyclopaedias of various fields. Large number of dailies, weeklies, periodicals are being subscribed by the library on regular basis. The library provides Circulation services, Technical services (i.e classification and cataloguing services) Reprographic Services i.e. Photocopier Service etc. to the users. Internet facility is also being provided.

#### Library Membership

Students need to furnish their fee receipt and college identity card to become a member of the library. Membership is yearly, and clearance needs to be taken at the end of every academic session. Library Reader Tickets (cards) are non-transferable.



#### Library Cards

- Students are given four (04) Library Reader's Tickets (Computer Science (H)-05) which can be used at the same time to facilitate readings. On Library Reader's Ticket No. 4 book will be issue for one day only and on rest of the Library Reader Tickets books will be issued for fifteen days.
- For books not returned on time, an overdue charge of Rs.5/- per day per book will be levied for the first week, Rs.10/- per day for the second week, Rs.25/- per day for the third week and in fourth week if the book is not returned, the library membership of the student shall invite cancellation.
- Students have to show College I-Card at the entry gate of library and while issuing the library books. Without showing I-Card at the library counter no book will be issued.
- Students cannot carry any bags into the library.
- In case of transfer of library tickets the ticket of the original card holder will be cancelled.
- In case of tearing of pages from any book is reported, strict disciplinary action will be taken.
- If a Reader/member lost his/her library ticket, a duplicate library ticket will be issued to him/her in the next academic year to avoid any kind of misuse of the library tickets.
- Fine for lost Reader's Ticket will be Rs.100/- per card. Fine of Rs.50/- towards the issue of Duplicate Card will be charged.
- Duplicate cards due to repeated loss of Reader's Tickets shall be considered only after prior approval of the Principal.
- Books on loan can be called at any time without assigning any reason thereof.
- The Library Membership Form is to be submitted after admission is secured.

## FACILITIES

#### **Sports Facilities**

The Sports Department is fast becoming one of the favourite with ample facilities and infrastructure for participation in sports both indoor and outdoor. A special room for playing table tennis, carom board and chess has been set up. The college campus also has badminton, lawn tennis, volleyball, basketball courts and a huge ground for playing cricket and football. It also offers gym facilities with latest equipment and machines for those interested in it.

#### **College Connectivity**

The college is well connected by various means of public transport. College is well connected by DTC services i.e., 85Ext, 196Spl, 442Spl, 951Ltd, 289D. The Metro Feeder bus(s) connects the college to Netaji Subhash Place Metro Station (Via Britannia), Kirti Nagar.

Students can deboard at NSP/Kirti Nagar/Kohat/ Pitam Pura Metro Station and use feeder bus service, DTC bus or auto rickshaw to reach college.

#### **Bus Pass**

The college provides the facility of concessional bus passes for its students, which is available on demand and has arrangement for the verification of DTC Bus Pass form.

#### Rail/Air Concession

The facilities for Rail/Air concession are available to the students at the college office for visiting their parents at their home town (to and fro) during vacations only. For this purpose, the permanent address declared in the admission form is considered. Any change in permanent address will be made only if the information is given to the office directly by the parents as soon as it takes place and not at the time when a concession is desired.

#### Photocopying

The facility of photocopying is available during admission in the administrative office on paid basis.

#### ATM

An ATM machine is installed in the college by Canara Bank for providing easy banking services to student and staff.

#### Cafeteria

The Cafeteria at Keshav Mahavidyalaya provide great food at affordable prices in a good atmosphere make the cafeteria the most frequently visited place in the college. Cafeteria is the place where students from all the streams meet and interact, over steaming cups of tea/coffee.



#### Garden

The college has well developed gardens which provide a lavish green look to the campus. It also maintains foliage for ecological balance and artistic look. Attractive lawns with blossoming flowers all around the campus present a delicate view.

#### Medical Room

The college have First-Aid Room for emergency purpose for resident as well as hostel students. In case of serious illness student or staff member reach to Bhagwan Mahaveer Hosiptal which is located next to college.

#### Internet/Wi-Fi Access

The college campus is well connected through wired as well as wireless networks. The coverage of Wi-Fi is not only restricted to class rooms but also extends to all the areas including library, auditorium, amphitheatre and cafeteria. Eventually, it enables Keshav Mahavidyalaya to switch over to innovative and recent teaching and learning methodologies.

The Annual Day is held in the college every year. On this day, the deserving students are felicitated. The University, College and House Examination toppers, and achievers in other extracurricular activities are rewarded for their achievements with certificates and medals.

#### Farewell

As the journey down the lane of undergraduate life draws to a close, the juniors bid adieu to the graduating students by holding a Farewell function in early April.



### IMPORTANT INFORMATION

#### LIBRARY MEMBERSHIP

Students need to furnish their fee receipt and college identity card to become a member of the library. Membership is yearly, and clearance needs to be taken at the end of every academic session. Library cards are non-transferable.

#### **IDENTITY CARD**

Every student will be issued an identity card which he/she should always carry and produce on demand. Failure to do so is liable for disciplinary action. I-card must be returned when student leaves the college. Loss of I-card should be reported to the office immediately.

#### STUDENT AID FUND/FEE CONCESSION

The college gives assistance to students belonging to relatively weaker sections of society in form of text books and cash. The college also gives fee concession to the deserving students. All the students can apply for same in the beginning of the session.

#### NOTICE BOARD

All notices regarding schedule of classes, holidays, examinations activities and other relevant information are posted on the notice boards. It is important for students to read these notices regularly. Ignorance of any notice will not be accepted as a plea for delay in any matter.

#### DISCIPLINE

The college expects its students to conduct themselves in a disciplined and dignified manner in the college and outside. For this purpose, some provisions are as follows:

- 1. Students are responsible for their conduct to the Principal and are prohibited from doing anything, whether inside or outside the college, that will amount to a breach of discipline or interference in the discipline and normal working of the college. A student shall be liable to disciplinary action for violation of any of the rules of discipline. Disciplinary action may involve warning and/or fine, and/or suspension from classes, from the examination, from use of the college Library or even from the college as such or any such actions as provided for in ordinance XV (B) and XV (C) of the Rules of discipline of the University of Delhi.
- 2. Students shall conduct themselves in gentlemanly, manner both towards the members of the staff (teaching and administrative) and towards their fellow students. Insubordination language or ungentlemanly conduct including teasing etc. shall be severely dealt with.
- 3. Students shall maintain perfect silence in classrooms and resist from demonstrations or disorderly behaviour. They must not loiter in the corridors or in front of classrooms or office room, and must keep as quiet as possible at all times. During their free periods, students should work, quietly in Library or reading room or spend the time in the student's common room but without causing any disturbance.
- 4. Delhi University is partnering with Delhi Police and World Lung Foundation South Asia, in promoting a tobacco free environment. As a step in that direction, smoking is banned in the college. The Anti-Smoking Nodal officer is Dr. Dhanpal Singh.
- 5. Students shall take proper care of the college furniture and premises and they must not spoil or cause any damage to or temper with college property, furniture and fittings. Cleanliness of the college premises and lawn must be maintained.
- 6. No Society can be formed in the college without permission of the Principal nor shall any person be invited to address a meeting in the college without prior permission of the Principal.
- 7. Students suffering from any contagious or infectious disease will not be permitted to attend the college.

8. Ragging in any form is strictly prohibited within the college premises. Any individual or collective act or practice of ragging constitute gross indiscipline and shall be dealt under ordinance XV.

### DISCIPLINARY ALERTS

The following activities are strictly prohibited:

- 1. Ragging
- 2. Stealing of any kind.
- 3. Defacing /Damaging the college walls, property and infrastructure.
- 4. Use of Mobile phones during classes.
- 5. Playing of music through mobile phones/ i-pods/ car-stereo etc.
- 6. Misbehaviour with peers, teaching and non-teaching staff.
- 7. Sitting on the stairs and loitering in the corridors.
- 8. Smoking and consumption of alcohol (in any form) in college premises.
- 9. Playing with crakes and hooliganism during festivals.
- 10. Littering in the college premises.

The students found guilty of indulging in any of the above or related activities would be appropriately punished and heavily penalized.

#### Ordinance XV - B: Maintenance of Discipline among students of the University

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance, the following shall amount to acts of gross indiscipline:
  - (a)Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/ Department and against any student within the University of Delhi;
  - (b) Carrying of /or threat of use of any weapons;
  - (c)Any violation of the provisions of the Civil Rights Protection act, 1976;
  - (d) Violation of the status, dignity and honour of students, belonging to the scheduled castes and tribes;
  - (e)Any practice-whether verbal or otherwise derogatory of women;
  - (f) Any attempt at bribing or Corruption in any manner;
  - (g) Wilful destruction of institutional property;
  - (h)Creating ill-will or intolerance on religious or communal grounds;
  - (i) Causing disruption in any manner of academic functioning of the University system;

(j) Ragging as per Ordinance XV - C.

- 4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor may in the exercise of his/her power aforesaid:
  - (a) Order or direct that any student or students be expelled; or
  - (b) Any student or students be, for a stated period, rusticated; or
  - (c) Any student or students be not for a stated period admitted to a course or courses of study in a college, department or institution of the University; or
  - (d) Any student or students be fined a sum of rupees that may be specified; or
  - (e) Any student or students be debarred from taking a University or college or departmental examination or examinations for one or more years; or
  - (f) That the result of the student or students concerned in the examinations in which he/she or they have appeared be cancelled.
- 5. The Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads Teaching Departments in the University, the Principal, School of Correspondence Courses and Continuing Education and Librarian shall have the authority, to exercise all such disciplinary powers over students in their respective colleges, Institutions, Faculties and Teaching Departments in the University as may be necessary for the proper conduct of the institution, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to, such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
- 6. With our prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of the Halls, Deans of Faculties, Heads Teaching Departments in the University. Each student shall be expected to provide himself/herself with a copy of these rules.
- 7. At the time of admissions, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the acts, the Statutes, the Ordinances and the rules that have been framed there under by the University.

### Prohibition and Punishment for Ragging

Ragging in any forms is strictly prohibited. The complaints of ragging shall be dealt under regulations 2009 notified on DU website: www.du.ac.in. In addition to the provisions of Ordinance XV C, all other measures decided upon by the Honourable Supreme Court of India, Ministry of HRD and the UGC would be binding on the University, Colleges.

#### Ordinance XV-C: Prohibition of and Punishment of Ragging

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department of Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under the Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts of practices which
  - (a) Involve physical assault or threat or use of physical force;
  - (b) Violate the status, dignity and honour of women students;
  - (c) Violate the status, dignity and honour of students belonging to the scheduled castes and tribes;
  - (d) Expose students to ridicule and contempt and affect their self-esteem;
  - (e) Entail verbal abuse and aggression, indecent gestures and obscene behaviour.
- 4. The Principal of a College, the Head of Department or an institution, the authorities of College or University Hostels or Halls or Residence shall take immediate action on any information of the occurrence of ragging.
- 5. No withstanding anything in Clause (4) above, the Proctor may suo moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advice the Vice-Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in clause 3 (a), (b) and (c), the Vice- Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-Chancellor may in other cases of ragging order or direct that a student or students be expelled or be not for a stated period admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case where students who have obtained degrees or diplomas of Delhi University are found guilty under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diploma conferred by the University.
- 12. For the purpose of this Ordinance, abetment to ragging will also amount to ragging.

13. All institutions within the Delhi University system shall be obligated to carry out instructions/directions issued under the Ordinance and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance. NOTE:

"Order of the Vice-Chancellor in pursuance of ordinance XV (c) : Where incident (s) of ragging are reported to the Vice-Chancellor by any authority under this ordinance, the student(s) involved in ragging shall be expelled for a specified term designated in the order: non-students involved in reports of ragging will be proceeded with under the Criminal Law of India, they will also be rendered ineligible for a period of 5 years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note will be given post decisional hearing, with strict adherence to the rules of natural justice."

### Sexual Harassment Committee

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAW AND JUSTICE) is based on the policy against Sexual Harassment by the Delhi University and seeks to maintain and create an academic and work environment free of Sexual Harassment for students, academic and non-teaching staff of Delhi University. The Ordinance will also apply to outsiders & residents, on the Delhi University camps, to the extent specified herein these rules and procedures.

### INTERNAL COLLEGE COMPLAINTS COMMITTEE

As per Ordinance XV-D of University of Delhi based on the policy against sexual harassment, (details on University website), an Internal College Complaints Committee (ICC) is set up for the prevention, prohibition, and redressal of sexual harassment of woman so as to create and maintain an academic environment free of sexual harassment of students and staff (teaching and non-teaching).

# Annexure I: GUIDELINES FOR ADMISSION ON THE BASIS OF SPORTS IN UNDER-GRADUATE COURSES 2015

The Colleges have to notify number of seats under Sports Quota (supernumerary) and requirement of sportspersons in different Sports/Games along with the respective position / event on their College Website and Notice board well in advance i.e. before the Pre-registration schedule of under-graduate courses is announced by the University.

### I. Super Category: Direct Admission without Sports Trials

Sportspersons who have participated / represented the country in the following Competition(s):

- a. Olympic Games by International Olympic Committee
- b. World Championships under International Sports Federations (IOA and / or MYAS recognized / affiliated Games)
- c. Asian Games by Olympic Council of Asia
- d. Asian Championships under International Sports Federations (IOA and / or MYAS recognized / affiliated Games)
- e. Commonwealth Games, S.A.F. Games and Afro-Asian Games (IOA and / or MYAS recognized / affiliated Games)
- f. Paralympic Games (IOC/IOA and / or MYAS recognized / affiliated Games)

### II. Admission with Sports Trials

- a. Maximum 50 Marks are for Sports Certificates (chart enclosed)
- b. It is essential for the candidate to qualify any one of the following Fitness Test items for consideration of admission in Archery, Chess and Shooting, and any two of the following Fitness Test items for consideration of admission in other Games/Sports as per the standards laid down by the University.

- i. The Fitness Test will be conducted by the Committee constituted by Delhi University Sports Council in the University Polo ground and the result of Fitness Test will be notified on the D.U. Website (www.du.ac.in) under the web link Delhi University Sports Council and Delhi University Sports Council Notice board as well.
- ii. The date and time of Fitness Test will be notified by the University along with the under-graduate admission schedule.

Fitness Test is the qualifying test for subsequent process of marking of Sports Certificates and Sports Trials and does not entitle the candidate for admission on the basis of Sports

- iii. The Delhi University Sports Council shall videograph the Fitness Test.
- C. The Colleges will conduct and videograph the Sports Trials.
- D. Maximum 50 Marks are for Sports Trials which include skill test, game performance test, game specific fitness, fundamentals of the game / sport etc.
  - i. Minimum 18 marks are required to be obtained by the candidate in the Sports Trials for admission on the basis of Sports.
  - ii. Evaluation and Marking shall be done by the technical hands of Sports Admission Committee.

#### Note:

- a. An Undertaking on Judicial Stamp paper of Rs. 100/- shall be submitted by the selected sportspersons at the time of admission stating that he/she will play for the College and University, all the years, during his/her under-graduate course of Study.
- b. The candidate should submit a self attested copy of the certificates along with Application/ Form.
- c. The candidate submitting false / fake certificate will be debarred from admission to any course in any College for three years. If he / she is admitted on false/fake certificates, his/her admission will be cancelled and such cases will be notified to all the Colleges.
- d. The level of Competency of the candidate in the Sports will be determined only for those who have achieved distinction in Sports during the last three years in the Sports / Games recognized by AIU and IOA. Preference will be given to Sports / Games in which Delhi University Inter-College and
  - a. Inter-University Competitions / Tournaments are held.
- e. The candidate as per his/her age must be eligible to participate in Inter-University Competitions/ Tournaments for the next three years and should not be employed Part-time / Full time anywhere.

### I. Eligibility Criteria

Any outstation/ NCR girl student who has secured admission to any Course offered by the college is eligible for Hostel Accommodation.

### II. Admission Procedure

- a. Girl students (Outstation / NCR) admitted in any regular undergraduate course at the college have to submit the duly filled 'Hostel Admission Application Form' (free of cost) available in the warden office in the hostel after showing College Admission Fee Receipt.
- b. The selected student has to submit all the forms (available in the Hostel Information Bulletin) duly filled in together with the required documents to the Warden. After this the student is required to pay the annual Hostel fees, and mess charges (for one semester only) within the stipulated time. (For further details, refer to the Hostel Information Bulletin).
- c. The student who fails to deposit the Hostel fee within the stipulated time shall lose the Hostel seat, and may be considered at the end only if seats are vacant.
- d. The final admission/ re-admission to the Hostel shall be subject to the fulfillment of eligibility conditions. The final decision in this regard shall remain with the college authority.
- e. Students are advised to regularly check the College/Hostel Notice Board and College Website for relevant information. No individual intimation will be sent in this regard.

#### Note:

If a student does not avail the hostel seat according to the admission schedule, she loses her priority in the admission list. Late applicants and those students who do not deposit the Hostel fee in the stipulated time will have no claim on the hostel seat.
