No nomination form will be accepted after 3:00 p.m. on Wednesday, 10th September, 2025, in any case.**
- Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College Identity Card. No withdrawal shall be allowed after 12.00 noon on Thursday, 11th September, 2025.
