Vs University of Delhi & Ors., Delhi Metro Rail (O & M) Act 2002, Prevention of Damage to Public Property Act 1984, The Delhi University Acts & Statutes, The Delhi Prevention of Defacement of Property Act, 2007, Hon'ble National Green Tribunal Order in O.A. The filled-up nomination form duly verified by the Principal, should be deposited in the sealed boxes kept in Room No. 115 (Chemistry Lab - 2) of the College from Monday, 8th September, 2025 (11:00 a.m. to 5:00 p.m.), Tuesday, 9th September, 2025 (10:00 a.m. to 5:00 p.m.) and Wednesday, 10th September, 2025 (10:00 a.m. to 3:00 p.m.), along with a **Demand Draft of Rs. 500/- in favor of the Principal, Keshav Mahavidyalaya, University of Delhi, from any nationalized bank, a Surety Bond, and an Indemnity Bond by way of affidavit (Affidavit on Rs. 100/- stamp paper duly attested and notarized)**. No nomination form will be accepted after 3:00 p.m. on Wednesday, 10th September, 2025, in any case.
5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College Identity Card. No withdrawal shall be allowed after 12.00 noon on Thursday, 11th September, 2025.
