The filled-up nomination form duly verified by the Principal, should be deposited in the sealed boxes kept in Room No. 115 (Chemistry Lab 2) of the College from Monday, 8th September, 2025 (11:00 a.m. to 5:00 p.m.), Tuesday, 9th September, 2025 (10:00 a.m. to 5:00 p.m.) and Wednesday, 10th September, 2025 (10:00 a.m. to 3:.00 p.m.), along with a Demand Draft of Rs. 500/- in favor of the Principal, Keshav Mahavidyalaya, University of Delhi, from any nationalized bank, a Surety Bond, and an Indemnity Bond by way of affidavit (Affidavit on Rs. 100/- stamp paper duly attested and notarized). No nomination form will be accepted after 3:00 p.m. on Wednesday, 10th September, 2025, in any case.
- 5. Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with copy of College Identity Card. No withdrawal shall be allowed after 12.00 noon on Thursday, 11th September, 2025.
