The house was informed by the principal and member secretary that college has not been able to pay salary for the month of March'20 to its employees because of unavailability of funds and present grant in aid order has made available funds for only salary of one month that too with a deficient amount of Rs Twenty lacs and no provision for payment of other than salary committed expenses for Electricity, water, Telephone bills etc.

It was also informed to house members that after payment of Salary for the month of March'20, College shall be left with an approximate balance amount of Rs Four lacs only. Hence College will not be able to pay salary for the month of April'20 its staff members {(Permanent-teaching, non- teaching), Adhoc faculty, contractual employees and Pensioners}. The Chairperson and Treasurer both suggested to pay the contractual staff members first over pensioners or other staff members as contractual employees thrive on a meager salary of around Rs 15000/- per month and in the likely hood of no savings, the survival of these employees shall be most difficult. The house members unanimously agreed and resolved to pay salary for the month of April'20 to its contractual employees at the moment and as per suggestion to other employees/pensioners in the specific order of preference under situation of financial constraints - Contractual, Pensioners, non- teaching, Adhoc and Permanent.

- 5. Receipt of letter No.: DHE-03(01)/100%/GIA/2020-2021/41 dated 07.05.2020 from the Account Officer, Directorate of Higher Education, Govt. of NCT of Delhi regarding Compliance of guidelines/conditions issued by the Finance Department was reported recorded and adopted.
- 6. Receipt of letter dated 5th February'20 from Mr Sandeep Vodwal, Assistant Prof. Department of Commerce in respect of his half yearly progress report while pursuing his PhD from Faculty of Management Studies, University of Delhi was reported and recorded. His request for grant of extension for one more year after completion of 1st year of his PhD to continue doing his PhD work was reported recorded and approved. The continuation of services of Adhoc faculty in lieu of study leave of Mr Sandeep Vodwal was also approved.
- 7. Inquiry report along with submission of relevant documents related to Online interactive meetings of the committee members with Complainant faculty member and the student responsible for misconduct and his father's own apologetic statement were reported recorded and thoroughly discussed. The governing body members took cognizance of the written signed apology by the student and his father along with recorded video-conference meetings

and written statement (via email) of the Complainant faculty member who was satisfied with the apology letter of student and undertaking by both the student and his father for good behavior of his son in future and personal acceptance of faculty to not pursue the case further. After due deliberations the governing body unanimously decided to revoke the suspension of the student with immediate effect and to write in the order to be served to him that in case Mr. Saahil Khanna in future is found to indulge in another instance of misconduct, then a stern action will be taken against him even amounting to his expulsion from the college.

The meeting ended with a vote of thanks to the chair.
