### MINUTES

A meeting of the Governing Body of the college was held on Wednesday 02.09.2025 in the Committee room of the Principal office.

The following members attended the meeting:

1. The Governing Body resolved that the Minutes of Governing Body meeting held on 27.08.2025 be confirmed and in addition matter was raised under "Any Other Matter" by a Teacher Representative regarding the post sanctioned for Senior Technical Assistant (STA) in the Department of Commerce and Mathematics.
2. The issue regarding strike of Non-Teaching staff members was discussed and deliberated. Many of their demands were agreed upon and conveyed to them through their Non-Teaching Representative in GB. However, the College Non-Teaching members did not agree upon and they decided to continue with their strike. It was decided that the Principal and Chairman shall discuss the matter with Registrar / Dy. Registrar for further guidance.
3. The issue of strike by Teaching Staff members was discussed and deliberated. The Chairperson was informed about the letter of DUTA dated 30.08.2025 addressed to the Principal in reference to the representation received from the Staff Association of Keshav

Mahavidyalaya. The Governing Body resolved that the college should continue to use ERP for various activities of students as well as administrative, accounts etc. The teachers shall submit hard copy of monthly attendance of students. The college website needs to be redeveloped as it is getting hacked almost every other day.

4. The house approved the creation of two posts of Director Physical Education – One Lady DPE and one Male DPE as the student strength has crossed 2000 and out of that 710 female students are currently enrolled in the college.
5. Appointment of two Assistant Professor(s) on Guest basis in the Department of Management Studies was reported against one vacant sanctioned position and one additional vacancy as per NEP requirements of 4<sup>th</sup> Year.
6. Appointment of six Assistant Professor(s) on Guest basis in the Department of Commerce was reported against two vacant sanctioned positions and four additional vacancies as per NEP requirements of 4<sup>th</sup> year.
7. Under any other matter, the following was discussed and resolved as follows:
  - (i) Medical bills for reimbursement should have a GST No. and all medical bills can either be computerized or handwritten with legitibly written names of medicines. All the medical bills should be cleared within one month of submission. Also the bills should be submitted in Accounts Office for speedy action.
  - (ii) Opening of Gate No. – 3 for student's entry and exit, the Principal informed that due to insufficient manpower, this cannot be considered at the moment. Further the

crossing at Gate No. – 3 is unmanned and prone to accidents. It needs proper planning with Traffic Police.

(iii) The Principal informed that both the Teacher Representatives and former President, Keshav Mahavidyalaya Student Union (KMVSU) requested for additional G.E papers (EVS, Physical Education and English) may be offered to the first Semester students. The house resolved that students admitted from 03.09.2025 onwards and have not filled the G.E papers shall be offered to choose amongst three additional G.E papers as well as stated above.

(iv) An International Conference on Interdisciplinary Pathways to Mental Health & Wellbeing is scheduled to be organized by Psychology Department of Keshav Mahavidyalaya at University of Delhi. The faculty members of Psychology Department of college requested for some monetary help from the college. They are approaching ICMR, ICSSR and SAP for financial grant to organize above International Conference.
