The Principal informed the members about the pending court case filed by Mr Anmol Panwar on behalf of Mr Pankaj Gaur regarding their plea to take stay on the Election agenda under item no 2 of the GB meeting schedule for 31st July'20 for the post of Chairman Governing Body of the College and regarding appointment of Treasurer, GB under agenda item number 3. The case was heard in High court on 27th July'20. The principal informed the members that court had not granted stay for the elections. However, the court order in the case was yet not uploaded on the court website.

The members from Delhi Government panel requested Prof Daman Maam and Prof Satish ji to continue as interim Chairperson and Treasurer of the present new GB too till the college received the name of one more member from University of Delhi. However, members expressed their desire to strictly follow University of Delhi guidelines in this matter or the court directives.

After lot of discussion and deliberations, it was unanimously resolved to hold the meeting on 7th August'20 and follow the court order which would have been received by 1st August'20.

The meeting ended with vote of thanks to all the members.
