1. The matter regarding financial crises and extreme hardships faced by staff members due to non receipt of Grant-in-Aid for salaries since the last five months and to explore possibilities to grant them some relief was reported and recorded. The Governing Body members after lots of discussion and deliberations upon the matter suggested the college to wait till 4th November, 2020 to hear the outcome of case filed by the DDU College and some other colleges regarding payment of salary and Grant-in-Aid. Further the house directed the college to write a letter to Directorate of Higher Education explaining the financial crises faced by staff members due to non receipt of Grant-in-Aid for more than 5 months and for seeking their approval to take loan from Student Society Fund Account on temporary returnable basis to pay at least two months' salary to staff members out of the 5 months salary due to them. The loan to be returned once Grant-in-Aid for Salary and other than salary expenses is received.

The meeting ended with a vote of thanks to the chair.
