1. The hostel facility shall be available only for students of Keshav Mahavidyalaya from **11th Aug 2026** onwards.
2. The applicant, along with parents and Local Guardian, is required to report on working days for verification from **11th – 14th August, 2026 between 10:00 am to 1:00 pm** at Hostel, with original filled-in and duly signed forms (namely Hostel Accommodation Form, Hostel Admission Form, Hostel Identity Card, Medical Fitness Certificate, **Notarized Anti Ragging Certificate** and Undertaking), CUET Scorecard and receipts for College fees, Hostel Fees and Mess Charges. **Additionally, copy of Category Certificate (on the basis of which admission has been sought, if applicable) needs to be submitted.**
3. This list is tentative and admission to hostel accommodation is subject to verification of all the documents and payment of Hostel Fees (**84,600 INR**)[#] and Mess Fees (**3,500 INR per month**) **X (3 months).**

4. The decision by the college regarding allotment of Hostel accommodation is final and binding.
 5. In case a student applies for withdrawal within a period of 10 days from the date of fee payment, then the entire fee except admission fee of Rs. 500/- shall be refunded to her if and only if she has not occupied the hostel room yet. In other cases, only Caution money and Mess Advance* shall be refunded, after the resident has paid all her dues and vacated the room allotted to her. No interest shall be paid for the Caution Money and Mess Advance deposited.
- * Residents staying up to 15 days in a month shall pay 50% of the monthly mess fee. Stays exceeding 15 days will require payment of the full monthly mess fee
