- The filled-up nomination form duly verified by the Principal, should be deposited in the sealed boxes kept in Room No. 115 (Chemistry Lab - 2) of the College from Tuesday, 08<sup>th</sup> September, 2026 (11:00 a.m. to 5:00 p.m.), Wednesday, 09<sup>th</sup> September, 2026 (10:00 a.m. to 5:00 p.m.) and Thursday, 10<sup>th</sup> September, 2026 (10:00 a.m. to 3:00 p.m.), along with a Demand Draft of Rs. 500/- in favour of the Principal, Keshav Mahavidyalaya, University of Delhi, from any nationalized bank, and an Indemnity Bond by way of affidavit (Affidavit on Rs. 100/- stamp paper duly attested and notarized), Surety Bond on Rs. 100/- non-judicial stamp paper duly attested and notarized, Affidavit on Rs. 10/- stamp paper for each post.
- No nomination form will be accepted after 3:00 p.m. on Thursday, 10<sup>th</sup> September, 2026, under any circumstance.**
- Withdrawal will be permitted if it is submitted by the candidate in his/her writing and in person with a copy of College Identity Card. No withdrawal shall be allowed after 12.00 noon on Friday, 11<sup>th</sup> September, 2026.
